Solutions

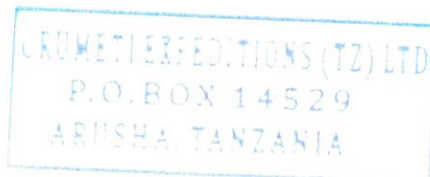
1. We are actively selling the destination through various agencies highlighting the differences in experiences and uniqueness of Tanzania as a destination.
