Re: Application for a TIC Certificate for Animal Care Company Limited

I write to you on behalf of Animal Care Company Limited, a registered company in Tanzania is a private limited company by shares and incorporated on 28 January 2011 with the Certificate of Registration Number 81209. The main activities of the company include manufacturing of animal premixes, animal feeds and all types of animal feed additives.

The company has been in the manufacturing and production of animal feed business for almost a decade and during this time, the company operations have expanded at a very fast pace and is increasing its operations even more so now due to the rising success of the operations.

Following the ever growing market of animal feed and to meet the needs of the consumers, the Board of Directors of the company have decided to expand the operations of the company further by introducing new products in the plant which would have a daily production capacity of 16 tons of animal feeds produced in a single day. At present, the daily production capacity stands at only 10 tons of animal feeds being produced in a day.

In addition to the above, the company is also seeking to invest in the production of soya beans and maize by setting up a soya beans and maize plant leading to a total investment of TZS 400,000,000. Soya beans and maize are the two main ingredients which are used in animal feeds' production.

Therefore, by investing in plants will increase the production activities of the company operations, the company will further seek to invest in increasing the number of warehouses so as to accommodate the huge amount of production activities and storage facilities. Currently the total number of warehouses held under the company are three. The investment for another two warehouses have been estimated to be around TZS 300,000,000.

The overall investment cost for the expansion of the company operations amount to TZS 3,500,000,000 which will be payable in the form of loan over a three year period and a further TZS 2,500,000,000 will be financed to support the existing animal feed production activities of the company. In addition to the above, the company is also seeking for an additional input of TZS 2,000,000,000 so that the production of maize meal can be procured and produced by the company.
