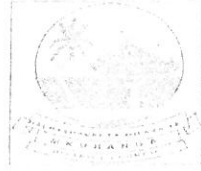

Halmashauri ya Wilaya ya Mkuranga imepokea maombi kutoka Kampuni ya **Lodhia Steel Industries Limited** ya S.L.P.12167 Arusha ikiomba viwanja tajwa hapo juu kugawanywa katika sehemu tatu zenye ukubwa tofauti, aidha katika nyaraka zilizowasilishwa mgawanyo huu umetokana na mauziano.

Awali umiliki wa Viwanja hivi ulikuwa chini ya umiliki wa Kampuni ya **Eagle Cement Company Limited** ya S.L.P.76770 Dar es salaam ambayo iliua viwanja hivi kwa Kampuni ya **Lodhia Steel Industries Limited** ya S.L.P.12167 Arusha, ambapo uhamisho wa miliki hii ulikamilika na kusajiliwa tangu tarehe 27/6/2018.

Kampuni ya **Lodhia Steel Industries Limited** imeuza sehemu ya Viwanja Na.1,2&3 kitalu B Kisemvule na kubakiwa na sehemu kubwa ya kiwanja Na. 1 Kitalu B Kisemvule, viwanja hivi vina ukubwa wa jumla wa mita za mraba 116,500 na mgawanyo umefanyika kama inavyoonyesha katika mabano. Kampuni ya **Lodhia Steel Industries Limited** amebakiwa na ukubwa wa mita za mraba (76,030) ambazo zitagawanywa mara mbili (mita za mraba 40,470 na mita za mraba 35,560 na kumilikishwa kwao). Kampuni ya **Ak-An Wood Limited** mita za mraba (12,141). Kampuni ya **Eco Plastics Limited** mita za mraba (12,141) na Kampuni ya **Kamaka IT Solution** mita za mraba (16,188). Kati ya Kampuni hizi zilizouziwa sehemu ya viwanja hivi, Kampuni mbili ni za ndani (Kampuni ya **Ak-An Wood Limited** na Kampuni ya **Kamaka IT Solution**), wakati Kampuni moja ya **Eco Plastics Limited** ni ya nje.



Halmashauri ya Wilaya imeandaa ramani ya Mipango Miji inayoendana na mgawanyo wa Ardhi uliofanywa na kuridhiwa na pande zilizouziana, mchoro Na. 92/02/92009A wa tarehe 11/6/2020

Utekelezaji wa mpango ulioandaliwa utafanyika baada ya urejeshaji kukamilika ikiwa ni pamoja na kufuta upimaji uliopo sasa ili kuruhusu upimaji upya kufanyika kwa ajili ya kumilikisha viwanja kwa Kampuni zilizouziwa.

Nawasilisha kwako nyaraka zote za mauziano LF Na.29,30,33 na 35 nikiambatanisha pia na LF Na.36, uthibitisho wa malipo ya capital gain clearance tax kutoka TRA sambamba na malipo yote yatokanayo na uhamisho wa miliki na urejeshaji hati.
