MEMORANDUM OF ASSOCIATION

OF

ARAL INTERNATIONAL LIMITED

1. The name of the Company is "ARAL INTERNATIONAL LIMITED"
2. The registered office of the Company will be situated in Tanzania.
3. The objects for which the Company is formed are:-
  - (a) To carry on the business of geological survey, exploration in mining, minerals such as Tanzanite, precious stones, gemstones, Diamond, Gold, silver and all minerals available in Tanzania, to become master brokers.
  - (b) To carry on the trades of iron-masters, steel makers, iron founders, brass founders, tinplate makers, colliery proprietors, cock manufactures, miners, smelters, engineers, and workers and dealers in aluminum, copper, brass, silver, steel, tin-plate, German-silver and all other kinds of materials in all their respective branches.
  - (c) To carry on the business of Agricultural farming and engage in all related fields including buying, stocking and selling agricultural, aquatic and forestry products and by products
  - (d) To carry on the business of farming of various food and cash crops and exporting the same, fruits canning, selling of canned/bottled fruit products, maize flour milling and selling of bagged flour, animal husbandry and selling of animal products such as milk, meat and skins.
  - (e) To acquire by purchase, lease, exchange or otherwise any building, estate or interest therein shares and hereditaments of any tenure or description situate anywhere in the United Republic of Tanzania, and any right(s) over or connected with land so situate and to lease, sell, dispose of the same or otherwise turn the same to account as may seem expedient,



- (l) To carry on the business of supplying computers, radios, televisions, tapes, desks, tables, chairs and other materials of a similar nature necessary for running schools, colleges and or universities.
- (m) To engage in and otherwise carry on the business of general food suppliers, catering services, fast food specialists, super potluck, lunch, dinner and or supper serving agents, reception, cocktail, conference, workshops, seminar and meeting coordinators, menus suppliers, wedding, sports, amusement, picnic and refreshment rooms services, all savory foods, consumable items of all kinds, type and description whatsoever.
- (n) To carry on the business of tour operators, hoteliers and safari promoters, tourist agents, transportation, car hirers, bailers and carriers of goods and passengers, cargoes of various kinds and as freight forwarders, to hire heavy vehicles like trucks, buses vans, minibuses, campers, mountain climbers, pick-ups for commutation of passengers and members of staff, employees working personnel, labourers of parastatal organizations, private and public bodies, companies, hotels, industrial, social, cultural educational and economical organization.
- (o) To provide maintenance services to all roads and highways, all kinds of buildings and structures generally to provide all repair and maintenance services to all kinds of harbors, dams, railways and airports.
- (p) To be suppliers of cement, roofing materials, sanitary wares, clay, bricks, steel bars, stones, sand, aggregates, asphalt, concrete, tar, all kinds of timber and wood and generally to be quarry masters and to be general suppliers of all kinds of quarry products.
- (q) To carry on the business of importing, exporting, distribution and selling of used motor vehicles, used spares, tires and tubes, used electrical goods of all sorts, machinery, refrigerators, televisions, compressors, radio and music systems, office machines, typewriters, electrical equipments, electrical appliances and clothing goods and to act as general merchants and commission agents of print and bind and manufacture stationers and other requirements.
- (r) To carry on the business as hoteliers and restaurant owners, caterers, safari lodgers, camps, motels, snacks, faces safari and tours, operator's of refreshment rooms, recreation gifts, kiosks, grocery, supermarkets, farming, cattle reapers, mining, fishing, hunting, transport agents, clearing and forwarding agents.

- (s) To carry on the trades of iron-masters, steel makers, iron founders, brass founders, tinplate makers, colliery proprietors, cock manufactures, miners, smelters, engineers, and workers and dealers in aluminum, copper, brass, silver, steel, tin-plate, German-silver and all other kinds of materials in all their respective branches.
- (t) To do all such business as book stores, selling and re-selling of various books, importation and exportation of books and book materials, books production, auctioning, exhibitions, designing, selling as wholesale or retail, marketing, establishing reader societies, clubs or all possible event to promote sustainable and profitable reading and writing of books on all disciplines.
- (u) To engage and or otherwise carry on the business of secretarial bureau and related business, transmission of facsimile messages, telex, international and local call services, photocopying, computer typing, printing, binding and labeling.
- (v) To carry on the business of broom and brushes manufacture, import and export, carpentry joinery and steel fabrication, manufactures, wholesalers, retailers and or representative for the above goods.
- (w) To carry on the business of timber and sawmill proprietors tree fellers, wood workers, joiners, carpenters, wood and timber merchants, woodwork contractors and varnishes, house furnishers, upholsters, furniture, and other floor coverings.
- (x) To carry of the business of transporters by land, sea, air and any other means of conveyance of people and goods in Tanzania and the neighborhood and in such other place or places as may from time to time be determined and deal with the import and export of all kinds of goods.
- (y) To carry any other trade or business whatever which can in the opinion of the Board of Directors be advantageously carried on by the Company in connection with the above business or the general business of the Company.

**AND** It is hereby declared that the word "Company" in this clause except where used in reference to this Company, shall be deemed to include any partnership or other body of persons, whether incorporated, and whether domiciled in Tanzania or elsewhere, and that the intension is that each of the objects set forth in any sub-clause or by the same of the company. None of such sub-clause or the objects herein specified or the powers thereby conferred shall be deemed subsidiary or auxiliary merely to the objects mentioned in the first sub-clause.


4. The Liability of the members is Limited.

The Company shall have powers to increase its capital and to divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such as preferential, deferred or special rights, privileges or conditions as may be determined by or in accordance with the Articles of Association of the Company.

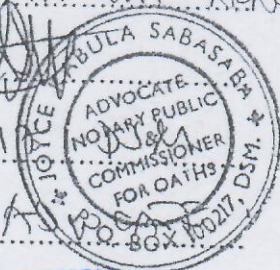


