We are the newly established company called Tantrail Company Limited incorporated on 4th February 2021 under the laws of United Republic of Tanzania and issued with Certificate of Incorporation No. 150317797. We have formed our company to provide tourism services as tour operating company in Tanzania. We are two shareholders/Directors in our company namely, Mr. Holger Andreas Schwarmer (58.33%), the Germany Citizen and Mr. Lenard Romel Mosha (41.67%), the Tanzanian Citizen. The authorized share capital of our company TZS 10 billion divided into 10,000 shares of TZS 1 million each.


Our project has the following social and economic impact
