Company Articles of Incorporation

Company name: Orm Global Ltd.

The terms in these articles are defined as set forth in the Companies Law 5759-1999 (hereinafter: "the Law").

- A. To partake in any legal activity and consult and execute infrastructure works and projects in Israel and abroad.
- B. To purchase, establish and manage agencies, warehouses, workshops and any real estate of any kind toward managing the company.
- C. To manage any business of equity holders, property owners, appointers, agents, emissaries, forwarders and contractors to accept to manage and execute all investment activities.
- D. To partake in any trade, search import, export, transport, supply, marketing, distribution, brokerage and handling of mechanical equipment, arrays and devices, work tools, accessories, containers, packages, raw materials, goods, products, merchandise and materials of any kind and for any use.
- E. To partake in research, searching, developing and utilizing natural treasures, to perform research in this regard and to hold, manage, finance, organize, engage research institutions, labs and delegations.
- F. To partake in transporting and shipping with any mode of shipment and transportation.
- G. To request, obtain, acquire, use, sell and transfer worldwide, plans, production processes, know-how, professional secrets, permits, licenses, possessions, franchises, leases, sponsorships and benefits of any kind entitling the company or authorized parties and/or authorizing parties to partake in businesses it is entitled to perform.
- H. To engage in agreements with any government and/or authority, whether central, municipal, local or other, around the world, in a manner that seems beneficial for company objectives, fully and/or partially, and to obtain from any such government or service any right, privilege or franchise that the company deems beneficial to obtain, use or execute.
- I. To take all actions that the company deems fit toward publicizing its actions and enterprises, especially by publication in print, radio and otherwise, through circulars, exhibitions and pamphlets and by granting awards and grants.
- J. To purchase or otherwise acquire and obtain any business, both as an existing business and otherwise, any property, assets, goodwill, rights and undertakings of any person where it may benefit the company or promote any matter included in the company objectives.
- K. To establish and found and/or participate in the establishment or foundation of any company in order to acquire or receive all or part of its property, rights, obligations and for any other purpose that the company deems may directly or indirectly help the said company promote any matter under any of the objectives of the said company.
