MEMORANDUM OF ASSOCIATION

of

BONSI INVESTMENTS LIMITED

1. The name of the Company is **BONSI INVESTMENTS LIMITED**
2. The registered office of the company will be in the United Republic of Tanzania
3. The purposes for which the Company is established is to carry on business as a general commercial company pursuant to section 7 of the Companies Act No. 12 of 2002 and more particularly the objects for which the Company is established are:
 - (a) To carry on the business of restaurant, canteen, bars and catering
 - (b) To sell, serve and distribute, manage, and market the manufacture of selling, serving and distribution of confection, pastries, biscuits, meat, bread, bread stuffs and all types of food stuffs and human consumables
 - (c) To sell, serve, distribute, manage, market, sell, serve and distribute soft drink, aerated waters and beverages
 - (d) To manufacture, buy, sell and generally deal in any plant, machinery equipment tools goods or things of any description which in the opinion of the company may be conveniently dealt with by the company in connection with any of its objects
 - (e) To apply for, purchase, or otherwise acquire and protect and renew in any part of the world any patents, patent rights, trade invention, trademarks, designs, licences, concessions, and the like, covering any exclusive or non-exclusive or limited rights to their use, or any secret or other information as to any invention which may seem capable of being used for any of the purposes of the company disclosed through the constructive work, or any work which the company is authorized to deal with
 - (f) To acquire by purchase, exchange or otherwise, whether in possession or in reversion, and whether vested or contingent, lands, houses, buildings, offices, workshops, premises and any fixed and moveable machinery, tools, engines, fixtures, plant, implements, patents, stock-in-trade, patents and patent rights, and fittings, ornaments and furnishings of any tenors, whether subject or

and to any charges, encumbrances, and to hold or to sell, let, alienate, mortgage, charge or otherwise deal with all or any of such lands, tenements, or hereditaments for the betterment of the objects of the company.

- (ii) To acquire and undertake the whole or any part of the business, goodwill, and property and liabilities of any person, firm or company carrying on or proposing to carry on, any of the businesses which the company is authorized to carry on, or premises properly suitable for the purpose of the company and as part of the consideration for such acquisition, to undertake all or any of the liabilities of such person, firm or company, or to acquire an interest in, amalgamate with, or enter into any arrangement for sharing profits, or for cooperation or for limiting competition, or for mutual assistance with any such person, firm or company, and give or accept by way of consideration for any of the acts or things allowed, or property acquired, any shares, debentures, debenture stock, or securities that may be agreed upon and to hold and to retain or sell, mortgage and give with any shares, debentures, debenture stock, or securities so received.
- (iii) To invest and deal with moneys of the company not immediately required upon each security and in such manner as may from time to time be determined.
- (iv) To purchase, lease or otherwise acquire, and to hold, let, improve, diversify, exchange, mortgage or otherwise dispose of any lands, buildings, machinery or plants, mills, factories, warehouses or any hereditaments in connection with the business of the Company.
- (v) To enter into any arrangements with any Government or authorities (supreme, municipal, local or otherwise) or any corporations, companies or persons having objects that may seem conducive to the company's objects or any of them, and to obtain from any such Government, Authority, Corporation, Company or person, any charters, contracts, licences, rights, privileges and concessions which the company may think desirable, and to carry out, exercise and comply with any such charters, contracts, licences, rights, privileges and concessions.
- (vi) To enter into partnerships or any arrangements for sharing profits, utility or interests, co-operation, joint ventures, alliances, concessions, or otherwise with any persons, firm or company carrying on or engaged in or about to carry on any business or transaction which the company is authorized to carry on, or engage in, or any business or transaction capable of being conducted so as directly or indirectly to benefit the company. And to lend money to, guarantee the contracts of, or otherwise assist any such shares and securities of any such company, and to sell, hold, receive with or without guarantee, or otherwise deal with the same.
- (vii) To provide any other company for the purpose of acquiring all or any of the property and undertaking, or any of the liabilities of this company or undertaking any business or operation which may appear likely to assist or benefit this company, or to enhance the value of the property or business of the company and to issue or guarantee the pricing of, underwrite, subscribe for or otherwise acquire all or any part of the shares or securities of such company as aforesaid.



- (iv) To lend and advance money or give credit to such persons, firm or companies and on such terms as may seem expedient, and in particular to customers and others having dealings with the company, and to give guarantees to ensure surety for the due payment of money for the performance of any obligations or liabilities.
- (v) To receive money or deposit or loan and borrow or raise money in such manner as the Company shall think fit, and in particular by the issue of debenture stock (interest or otherwise) and to secure the repayment of any money borrowed raised or owing by mortgage, charge or lien and to secure and guarantee the performance by the company or any other person or company of any obligation undertaken by the company or any other person or company. The bills may be.
- (vi) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, warrants, debentures and other negotiable or transferable instruments.
- (vii) To do all such other things as the Company may deem to be incidental or conducive to the attainment of all or any of the above objects or to do any other things that the directors may deem necessary and beneficial to the Company.

4. The liability of the Members is limited.

5. The share capital of the company is Tatarona Shillings Twenty Million only (Tats. 20,000,000) divided into Ten Thousand shares (2000) of Ten Thousand Tatarona Shilling (Tats. 10,000) each. The company shall have power to divide the original or any increased capital into several and to attach thereto any preferential, deferred, qualified or other special rights, privileges, restrictions or conditions.


The Company shall by a resolution of members have the power to amend or modify any of the conditions contained in the Memorandum of Association.

ARTICLES OF ASSOCIATION

of

BONSI INVESTMENTS LIMITED

1. In these Regulations:

"the Act" means the Companies Act;

Interpretation

"the articles" means the articles of the company;

"other days" in relation to the period of the notice means that period excluding the day when the notice is given or on which it is to take effect;

"the holder" in relation to shares means the member whose name is entered in the register of members as the holder of the shares;

"the seal" means the common seal of the company;

"secretary" means the secretary of the company or any person appointed to perform the duties of the secretary of the company;

Expressions referred to in writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and other modes of representing or reproducing words in a visible form.

Unless the context otherwise requires, words or expressions contained in these Regulations shall bear the same meaning as in the Act or any statutory modification thereof in force at the date at which these Regulations become binding on the company.

2. The Company is a private Company and accordingly:

Private Company

(a) the right to transfer shares is restricted in the manner as hereinafter prescribed;

(b) the members of the company (exclusive of persons who are in the employment of the Company) is limited to fifty.

PROVIDED THAT, where two or more persons hold one or more shares in the Company jointly, they shall, for the purpose of this Article, be treated as a single member.

- (cc) any invitation to the public to subscribe for any shares or debentures of the company is prohibited;
- (cd) the Company shall not have power to issue share warrants to bearer.

SHARE CAPITAL

- 3. The Share Capital of the Company at the date of registration of these Articles in Tanzania Shillings Twenty Million (Tsh. 20,000,000) and is divided into Two Thousand (2,000) ordinary shares of Ten Thousand Tanzania Shillings (Tsh. 10,000) each. Share Capital

LOANS BY THE COMPANY

- 4. No part of the funds of the Company shall be employed in the purchase of or in loans upon the security of the Company's shares. The Company shall not, except as authorized by the Act, give any financial assistance for the purpose of or in connection with any purchase of shares in the Company. Company's own shares not to be purchased

RIGHTS OF SHAREHOLDERS

- 5. Without prejudice to any special rights previously conferred on the holders of any shares or class of shares already issued (which special rights shall not be modified or abrogated except with their consent or sanction as is provided by the next following Article) any share in the Company (whether forming part of the original capital or not) may be issued with such preferred, deferred or other special rights, or such restrictions, whether in regard to dividend, return of capital, voting or otherwise, as the Company may from time to time by ordinary resolution determine, and subject to the provisions of the Act the Company may issue Preference Shares which are, or which at the option of the Company are to be, liable to be redeemed. MODIFICATION OF RIGHTS

- 6. Whenever the capital of the Company is divided into different classes of shares, the special rights attached to any class may, subject to the provisions of the Act, be modified or abrogated either with the consent in writing of the holders of three-fourths of the issued shares of the class, or with the sanction of a Special New rights of shares may be modified

Resolution passed at a separate General Meeting of such holders (but not otherwise), and may be so modified or abrogated either whilst the Company is a going concern or during or in contemplation of a winding up. To every such separate General Meeting all the provisions of these articles relating to General Meetings of the Company or to the proceedings thereof, shall mutatis mutandis, apply, except that the necessary quorum shall be two persons at least holding or representing by proxy one-half in nominal amount of the issued shares of the class (but so that if at any adjourned meeting of such holders a quorum as above defined is not present, those Members who are present shall be a quorum), and that the holders of shares of the class shall, on a poll, have one vote in respect of every share of the class held by them respectively.

In respect of a share or shares held jointly by several persons, the company shall not be bound to issue more than one certificate, and delivery of a certificate for a share to one joint holder shall be sufficient delivery to all joint holders.

11. If a share certificate be worn out, defaced, lost or destroyed, it may be renewed on payment on such terms (if any) as to evidence, indemnity, and the payment of expenses reasonably incurred by the Company in investigating evidence as the Directors may determine but otherwise free of charge, and in the case of the defacement or wearing out or delivery of the old certificate.

LIEN

12. The Company shall have a first and paramount lien on every share (not being a fully paid share) for all moneys (whether presently payable or not) called or payable at a fixed time in respect of such share; and the Company shall also have a first and paramount lien and charge on all shares (including fully paid shares) standing registered in the name of such Member (whether solely or jointly with others) for all the debts and liabilities of such Member to his estate to the Company and that whether the same shall have been incurred before or after notice to the Company of any equities or other claims in any person other than such Member, and whether the period for the payment or discharge of the same shall have actually arrived or not and notwithstanding that the same are joint debts or liabilities of such Member or his estate and any other person, whether a Member of the Company or not. The Company's lien (if any) on a share shall extend to all dividends payable thereon but the Directors may at any time declare any share to be exempt wholly or partially from the provisions of this Article.

Company's lien

13. The Company may sell, in such manner as the Directors think fit, any share on which the Company has a lien, but no sale shall be made unless a sum in respect of which the lien exists is presently payable, nor until the expiration of fourteen days after a notice in writing, stating and demanding payment of the sum presently payable, and giving notice of intention to sell in default, shall have been given to the holder for the time being of the share or the person entitled by reason of his death or bankruptcy to the share.

Sale of shares

14. For giving effect to any such sale the Directors may authorize some person to transfer the shares sold to the purchaser thereof. The

purchaser shall be registered as the holder of the shares comprised in such transfer, and he shall not be bound to see to the application of the purchase money, nor shall his title to the shares be affected by any irregularity or invalidity in the proceedings in reference to the sale.

21. The Directors may from time to time make arrangements on the issue of shares for a difference between the holders of such shares in the amount of calls to be paid and in the terms of payment. Power to differentiate
22. The Directors may, if they think fit, receive from any Member willing to advance the same, all or any part of the moneys unpaid upon the shares held by him beyond the sums actually called up thereon as a payment in advance of calls and such payment in advance of calls shall extinguish so far as the same shall extend, the liability upon the shares in respect of which it is advanced, and upon the moneys so received, or so much thereof as from time to time exceeds the amount of the calls then made upon the shares in respect of which it has been received the Company may pay interest at such rate as the Member paying such sum and the Directors agree upon. TRANSFER OF SHARES

23. Subject to the restrictions of these provisions, all transfers of shares may be effected by transfer in writing in the usual common form or in any other form in writing under hand approved by the Directors. Form of transfer
24. The instrument of transfer of a share shall be in writing and shall be signed by or in behalf of the transferor and transferee, and the transferor shall be deemed to remain the holder of the share until the name of the transferee is entered in the Register of Members in respect thereof, provided that the Directors may dispense with the execution of the instrument of transfer by the transferee in any case in which they think fit in their discretion so to do. Execution
25. The Directors may, in their absolute discretion and without specifying any ground, refuse to register a transfer of any share to any person who, in their opinion, it is undesirable in the interests of the Company to admit to membership. No transfer shall be registered if by any person formed the number of members would exceed the limit hereinafter prescribed. Director's refusal to register and issuing register
26. The Directors may refuse to register any transfer of a share where the Company has a lien on the share.

27. If the directors refuse to register a transfer, they shall, within two months after the date on which the transfer was lodged with the Company, send to the transferee notice of the refusal.

28. All instruments of transfers which shall be registered shall be retained by the Company but any instrument of transfer which the Directors may decline to register shall on demand be returned to the person depositing it with the Company.

The Directors may decline to register any instrument of transfer unless:-

(a) Such fee, as the Directors may from time to time require, is paid to the Company in respect thereof; and

(b) The instrument of transfer is deposited at the Office or such other place as the Directors may appoint, accompanied by the certificate of the shares to which it relates, and such other evidence as the Directors may reasonably require to show the right of the transferor to make the transfer.

TRANSMISSION OF SHARES

29. In case of the death of a Member the survivors or survivor where the deceased was a joint holder, and the executor or administrators of the deceased where he was a sole or only surviving holder shall be the only persons recognized by the Company as having any title to his shares; but nothing herein contained shall release the estate of a deceased holder (whether sole or joint) from any liability in respect of any shares solely or jointly held by him.

Transmission on death

30. Any person becoming entitled to a share in consequence of the death or bankruptcy of a Member may, upon such evidence as to his title being produced as may from time to time be required by the Directors, and subject as hereinafter provided, either be registered himself as holder of the share or elect to have some person nominated by him registered as the transferee thereof.

Registration of Executors and Transferees in Bankruptcy

31. If the person so becoming entitled shall elect to be registered himself, he shall deliver or send to the Company a notice in writing signed by him stating that he so elects. If he shall elect to have his nominee registered, he shall signify his election by executing to his nominee a transfer of such share. All the provisions, restrictions and provisions of these articles relating to the right to transfer and the registration of transfer of shares shall be applicable to any such notice or transfer as

27. A forfeited share shall become the property of the Company and may be sold, re-allocated or otherwise disposed of, either to the person who was, before forfeiture, the holder thereof or entitled thereto, or to any other person, upon such terms and in such manner as the Directors shall think fit, and at any time before a sale, re- allotment or disposition, the forfeiture may be cancelled on such terms as the Directors think fit. The Directors may if necessary, authorize some person to transfer any forfeited share to any such other person as aforesaid.

Sale of forfeited shares

28. A person whose shares have been forfeited shall cease to be a Member in respect of the forfeited shares, but shall, notwithstanding the forfeiture, remain liable to pay to the Company all moneys which, at the date of the forfeiture, were payable by him to the Company in respect of the shares, with interest thereon as shall be determined by the Directors from the date of forfeiture until payment, but the Directors may waive payment of such interest either wholly or in part and the Directors may enforce payment without any allowance for the value of the shares at the time of forfeiture.

rights and liabilities of Members whose shares have been forfeited

29. A statutory declaration in writing that the declarant is a Director or the Secretary of the Company, and that a share has been duly forfeited on the date stated in the declaration shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the share, and such declaration and the receipt of the Company for the consideration (if any) given for the share or the sale, re-allotment or disposal thereof together with the certificate of incorporation of the share under seal delivered to a purchaser or holder thereof shall (subject to the execution of a transfer if the same be required) constitute a good title to the share, and the person to whom the share is sold, re-allocated or disposed of, shall be regarded as the holder of the share and shall not be bound to see to the application of the purchase money (if any) nor shall his title to the share be affected by any irregularity or invalidity in the proceedings or reference to the forfeiture, sale, re-allotment or disposal of the share.

Title to forfeited share

INCREASE OF CAPITAL

40. The Company may from time to time by Ordinary Resolution increase its share capital by such sum to be divided into shares of such amount as the resolution shall prescribe.

Power to increase capital

41. The Company may by Ordinary Resolution direct that the new shares, or any of them shall be offered in the first instance, either at par or at a premium, to the then Members or to the holders of any class of shares for the time being, in proportion to the number of shares or shares of the class or group held by them respectively, or make any other provisions as to the issue of the new shares. Allocation of new shares
42. All new shares shall be subject to the provisions of these presents with reference to payment of calls, fees, transfer, transmission, forfeiture and otherwise and, unless otherwise provided in accordance with the powers contained in these presents, shall be Ordinary shares. ↪

ALTERATIONS OF CAPITAL

43. The Company may by Ordinary Resolution:-

- (a) Consolidate and divide all or any of its share capital into shares of larger amount than its existing shares. Power to consolidate shares.
- (b) Cancel any shares which, at the date of the passing of the resolution, have not been taken, or agreed to be taken by any person, and diminish the amount of its capital by the amount of the shares so cancelled. Power to cancel shares.
- (c) Sub-divide its shares, or any of them, into shares of smaller amount than is fixed by the Memorandum of Association (subject, nevertheless, to the provisions of the Act), and so that the resolution whereby any share is sub-divided may determine that, as between the holders of the shares resulting from such sub-division, one or more of the shares may have any such preferred or other special rights over, or may have such deferred rights, or be subject to any such restrictions as are provided with the shares as the Company has power to attach to unissued or new shares. - (d) Reduce its capital or any capital redemption reserve fund or any share premium account in any manner authorized by the Act. Power to reduce capital.

STOCK

44. The Company may by Ordinary Resolution convert any paid-up shares into stock, and reconvert any stock into paid-up shares of any denomination. Conversion into Stock.

45. The holders of stock may transfer the same, or any part thereof, in the same manner, and subject to the same regulations as are subject to which the shares from which the stock arose might previously to conversion have been transferred, or all four items as circumstances admit, and the Directors may fix time to time by the minimum amount of stock transferable but so that such minimum shall not exceed the nominal amount of the shares from which the stock arose.
46. The holders of stock shall, according to the amount of stock held by them, have the same rights, privileges and advantages as regards dividends, voting at meetings of the Company and other matters as if they held the shares from which the stock arose, but no such privilege or advantage (except participation in the dividends and profits of the Company and in the assets on winding up) shall be conferred by an amount of stock which would not, if existing in shares, have conferred that privilege or advantage.
47. Each of the regulations of the Company as are applicable, to stock-up shares shall apply to stock, and the words "share" and "shareholder" therein shall include "stock" and "stockholder".

GENERAL MEETINGS

48. A General Meeting shall be held as the Annual General Meeting once in every year, at such time (within a period of not more than three months after the holding of the last preceding Annual General Meeting) and place as may be determined by the Directors. The General Meetings referred to in this Article shall be called "Annual General Meetings". All General Meetings other than Annual General Meetings shall be called "Extraordinary Meetings".
49. The Directors may call an Extraordinary Meeting whenever they think fit and shall, on requisition in accordance with the Act, proceed to convene an Extraordinary Meeting as required by the Act. In the case of Extraordinary General Meeting called in pursuance of a requisition, unless such meeting shall have been called by the Directors, no business other than that stated in the requisition as the objects of the meeting shall be transacted.

NOTICE OF GENERAL MEETINGS

50. All meetings of Members shall be called by twenty-one days' notice in writing at the least. The notice shall be exclusive of the day on which it is served or deemed to be served and exclusive of the day for which it is given, and shall specify the place, the day, and the hour of meeting, and in case of special business, the general nature of such business.

(and in the case of a meeting convened for passing a Special Resolution, the intention to propose such resolution as a Special Resolution), and shall be given in manner hereinafter mentioned to such persons as are, under the provisions herein contained, entitled to receive notices from the Company. With the consent in writing of all Members entitled to receive notices from the Company, a meeting may be convened by a shorter notice and in such manner as such Members may think fit.

RESERVES

116. The Directors may from time to time set aside out of the profits of the Company and carry to reserve such sums as they think proper which shall at the discretion of the Directors be applicable for meeting contingencies or for the gradual liquidation of any debt or liability of the Company or for repairing or maintaining the works plant and machinery of the Company or for special dividends or bonuses or for equating dividends or for any other purposes to which the profits of the Company may properly be applied and pending such application may at the like discretion either be employed in the business of the Company or be invested in such investments (other than shares of the Company) as the Directors think fit. The Directors may divide the reserve into such special funds as they think fit, and may consolidate into one fund any special funds or any parts of any special funds into which the reserve may have been divided as they think fit. The Directors may also without obtaining the sanction of the members carry forward any profits which they may think it not prudent to divide.

117. The Directors may establish a reserve to be called the Capital Reserve, which shall not be available for dividend, but which shall be available to meet depreciation or contingencies or for repairing, improving, or maintaining any property of the Company or for such other purposes as the Directors may in their discretion think conducive to the interests of the Company, and the Directors may invest the sums standing to the Capital Reserve in such investments as they think fit, other than shares or stock of the Company, and may from time to time deal with or vary such investments and dispose of all or any part thereof with full power to employ the Capital Reserve in the business of the Company, and that without keeping it separate from the other assets and with power to divide the said Capital Reserve into separate accounts or funds if they think fit.

CAPITALISATION OF PROFITS AND RESERVES

118. The Company in General Meeting may, upon the recommendation of the Directors, resolve that it is desirable to capitalise any undivided profits of the Company not required for paying the fixed dividends or Preference Shares if any (including profits earned and standing to the

credit of any reserve or reserves or other special account), and accordingly that the Directors be authorized and directed to appropriate the profits received to be capitalized to the Members in the proportions in which such profits would have been divisible amongst them had the same been applied in paying dividends instead of being capitalized, and to apply such profits on their behalf either in or towards paying up the amounts, if any, for the time being unpaid on any shares held by such Members respectively, or in paying up in full unissued shares, debentures or securities of the Company of a nominal amount equal to such profits, such shares, debentures or securities to be allotted and distributed credited as fully paid up, in and amongst such Members in the proportion aforesaid, or partly in one way and partly in the other.

123. The Company shall at each Annual General Meeting appoint an Auditor or Auditors to hold office until the next ensuing Annual General Meeting. The Auditor's report shall be read before the Company at the Annual General Meeting and shall be open to inspection by any Member. The Auditor's duties shall be regulated in accordance with the Act.
124. No director or other officer of the company or any person who is a partner of or in the employment of an officer of the company, or any corporation, shall be capable of being appointed Auditor of the company.

NOTICES

125. Any notice or document may be served by the Company on any Member whoever resident either personally or by fax or e-mail or tele or by sending it through the post in a prepaid letter addressed to such Member at his registered address as appearing in the Register of Members; provided that if such address is outside Tanzania, such letter shall be sent by air mail. In respect of joint holdings, all notices shall be given to that one of the joint holders whose name stands first in the Register of Members, and notice so given shall be sufficient notice to all the joint holders.
126. Any notice or other document, if sent by fax or e-mail or tele shall be deemed to have been served as soon as the message has been transmitted, and if served by post shall be deemed to have been served 24 hours after the letter containing the same is posted, and in proving such service it shall be sufficient to prove that the letter containing the notice or document was properly addressed, stamped and posted.

127. Any notice or document delivered or sent by post to or left at the registered address of any Member in pursuance of these presents shall, notwithstanding that such Member be dead or bankrupt, and whether or not the Company have notice of his death or bankruptcy, be deemed to have been duly served in respect of any share registered in the name of such Member as sole or joint holder, and such service shall for all purposes be deemed a sufficient service of such notice or document on all persons interested (whether jointly with or as claiming through or under him) in the share.

WINDING UP



128. If the company shall be wound up (whether liquidation is voluntary, or under supervision, or by Court), the liquidator may with the authority of a Special Resolution, divide among the Members in specie or kind the whole or any part of the assets of the Company and whether or not the assets of the Company and whether or not the assets shall consist of property of one kind or shall consist of properties or different kinds and may for such purpose sell such value as he deems fit upon any one or more class or classes of property and may determine how such division shall be carried out as between the Members or different classes of Members. The liquidator may, with the like authority, vest any part of the assets in trustees upon such trusts for the benefit of Members as the liquidator with the like authority shall think fit, and the liquidation of the Company may be closed and the company dissolved, but so that no contributory shall be compelled to accept any share in (respect of which there is a liability).

INDEMNITY

129. Subject to the provisions of the Act every Director, Managing Agent, Auditor, Manager, Secretary or officer or servant of the Company shall be entitled to be indemnified by the Company against all costs, charges, losses, expenses and liabilities incurred by him in the execution and discharge of his duties or in relation thereto.
130. No Directors, Managing Agent, Auditor or other officers of the Company shall be liable for the acts, receipts, neglects or defaults of any other Director or Officer, or for joining in any receipt or other act for conformity or for any loss or expense happening to the Company through the insufficiency or deficiency of title to any property acquired by order of this Directors for or on behalf of the Company, or for the insufficiency or deficiency of any security in or upon which any of the moneys of the Company shall be invested, or for any loss or damage arising from the

bankruptcy, insolvency or tortious act of any person with whom any moneys, securities or effects shall be deposited, or for any loss occasioned by any error of judgment, omission, default or oversight on his part, or for any other loss, damages or misfortune whatsoever which shall happen in relation to the execution of the duties of his office or in relation thereto, unless the same happen through his own dishonesty.
