The Good Grain Co. (Tz) Limited (the “Company”) is a limited liability company duly incorporated in the United Republic of Tanzania on 24 April 2025 under Certificate of Incorporation number 156330736. The company is affiliated to **Spice World Limited**, a regional leader in grain processing and food manufacturing headquartered in Nairobi, Kenya.

We are planning to start operations in Tanzania which involves end-to-end aggregation, processing, and export of grains. We will work directly with local farmers and cooperatives to source maize, sorghum, beans, and other cereals. We plan to instal modern grain cleaning plant in a purpose-built warehousing facility, which we have leased in Arusha, and have plans to construct in any others in strategic locations. We target to sell to both regional and global markets.

Our investment will deliver significant economic benefits to the people of Tanzania among them, creating direct employment opportunities across various roles including management, warehousing, logistics, field officers, quality control, and administration. Through our farmer engagement model, we will provide smallholder farmers with stable and transparent market access, resulting in increased incomes and improved livelihoods. Our export-oriented operations will generate foreign exchange earnings and contribute to the country's trade balance. Our investment will introduce improved post-harvest handling techniques and technologies that will be shared with farmer groups and cooperatives, enhancing their productivity and reducing post-harvest losses. Ultimately, our presence will help in positioning Tanzania as a regional sourcing and trade hub, deepening integration within the EAC and COMESA regions.

We anticipate an initial capital investment of approximately **USD 1,340,000** covering machinery acquisition, infrastructure development, and working capital requirements. The project will be financed through a combination of equity and debt capital structures.


