**RE: AMENDMENT OF CERTIFICATE OF INCENTIVES**

1. The above captioned subject matter kindly refers,
2. Our company has not been operational since 2017 after having not been granted renewal of power generation license by EWURA and the incarceration of our Executive Chairman Harbinder Singh Sethi at Ukonga Prisons from 17<sup>th</sup> June, 2017 until his recent release on the 16<sup>th</sup> June, 2021.
3. As a result the incarceration and operational lock down, our company could not generate power which is our core business; and now the company faces a number of debts payable to its staff (salaries and retrenchment benefits), suppliers, TRA, TANESCO, DAWASCO, Ministry of Lands and other government agencies, debts which need immediate action for payment to mention but few.
4. Up until the release of our chairman a number of his documents including work permit, resident permit and others of similar importance have expired and needs urgent renewal. In the course of lodging for renewal of these documents and due to a number of reasons beyond our control, we could not trace *inter alia* Certificate of Incentives issued to IPTL by TIC.
5. Our chairman and his fellow shareholders are currently in the process of reviving IPTL and hence invest more in the company and energy sector at large, and therefore are in urgent

need of certificate of incentives in order to enable subsequent processes of obtaining relevant license, permits and the like.

6. Further the shareholding of IPTL has also changed and we wish to have this updates reflected in the certificate of incentives. To this end we humbly wish to use this opportunity to request for an amendment of Certificate of Approval no. 121713 issued to IPTL dated 20<sup>th</sup> February, 1997 to reflect the current shareholding and other new developments to date.

7. we humbly request to indulge your good office to cause for an amendment and issue us with a new certificate to enable us process our numerous applications which *inter alia* require the attachment of a certificate of Incentives.

8. We thank you beforehand for your expedited and positive response to our humble request.
