The Mining Act, 2010

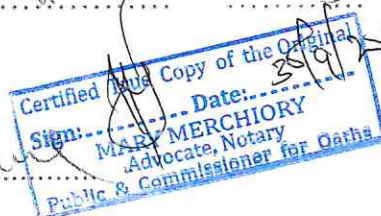

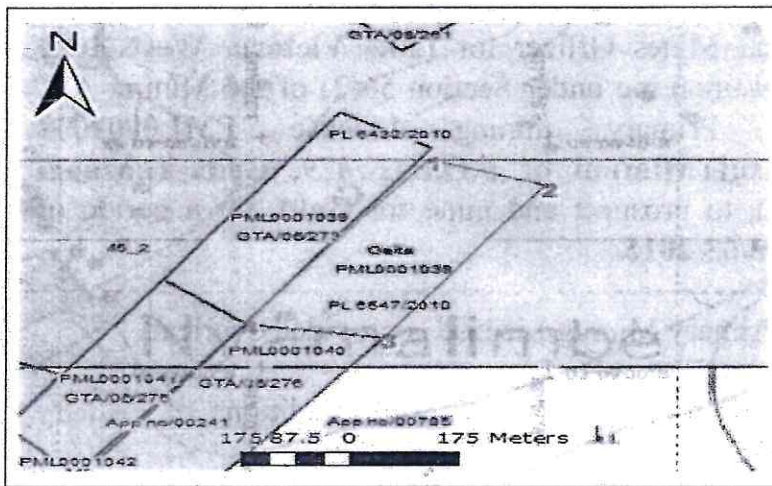
