AND FURTHER, except where otherwise expressed in such sub-clause, the objects set forth in any sub-clause shall not be in any way limited or restricted by reference from the terms of any other sub-clauses or the objects therein company. None of such sub-clauses or the objects therein specified or the powers thereby conferred shall be deemed subsidiary or auxiliary merely to the objects mentioned in any other sub-clause, and in non case is the generality of any one sub-clause to be narrowed or restricted by any particularity of any other sub-clause, nor is any general expression in any sub-clause to be narrowed or restricted by any particularity of

expression in the same sub-clause or by the application of any rule of construction, ejusdem generic or otherwise.

4. The liability of the members is limited.

5. The share capital of the Company is Tanzania Shillings Five Hundred Millions (500,000,000/=) divided into Twenty Five Thousand (25,000) ordinary shares of Tanzania shillings Twenty Thousand (20,000/=) each, with power of the company to increase or reduce the said capital and issue any part of its capital original or increased with or without any preference priority or special privilege or subject and so that unless the condition of issue shall other wise expressly decide every issue of shares whether declined to be preference or other otherwise shall be subject to the power hereinabove contained.
