**RE: EXTENSION OF TIME IN RESPECT OF THE CERTIFICATE OF INCENTIVE NO. 061471 ISSUED TO TANGA FRESH LIMITED**



- (b) The effects of Covid-19 pandemic which hugely affected the Company's business.
