CLAUSE EXPLANATION

条款说明

Unless otherwise proforma invoice herein, the terms used herein shall have the same meanings as they are in the International Rules for the Interpretation of Trade Terms 2010(INCOTERMS 2010) provided by International Chamber of Commerce.

除非本形式发票另有约定, 本形式发票的相关专业术语和条件与国际商会制定的《2010 年国际贸易术语解释通则》相一致。

The validity, interpretation and implementation of this proforma invoice shall be governed by the laws P.R. China.

本形式发票的有效性、解释和履行受中国法律管辖。

In the event of a dispute arises in relation to the interpretation or the implementation of this proforma invoice, the parties shall attempt to resolve such dispute through friendly consultation. If the parties are unable to resolve any dispute in this manner within 90 days of such dispute arising, the dispute may be submitted to the China International Economic and Trade Arbitration Commission. The arbitration place and the oral hearing place shall be in Ji'nan, China. Such arbitration shall be governed by the prevailing rules and procedures of arbitration stipulated by the China International Economic and Trade Arbitration Commission. The arbitration institute shall be conducted in Chinese. Any award made by such arbitral tribunal shall be final and binding upon both parties, who whereby exclude any right of appeal to any court which might otherwise have jurisdiction in the matter, The arbitration fees shall be borne by the losing party unless otherwise agreed.

双方同意对一切因执行和解释本形式发票所发生的争议, 努力通过友好协商解决。在争议发生的通知之日起一个合理的时间内, 最多不超过 90 天, 协商不能取得对买卖双方都满意的结果时, 则该争议应提交中国国际经济贸易仲裁委员会仲裁, 仲裁地和开庭地在中国济南, 并依据申请仲裁时现行的仲裁规则进行。仲裁程序应以中文进行。该仲裁为终局裁决, 对双方均有约束力。任何一方不得寻求法庭或其它机构更改仲裁裁决。仲裁费用除非另有约定, 由败诉一方负担。
