1. The name of the Company shall be GOOD SHEPHERD EDUCATION TRUST FUND (GSETF) LIMITED.
2. The registered office of the Company shall be situated in the United Republic of Tanzania.
3. The principal object for which the Company is established is to fight against illiteracy of all forms and promote education in all levels, to wit pre- primary education, primary education, secondary education trade schools, colleges and university level to the highest possible standard.
4. To promote and do all functions of and relating to tourism, tour guides and operators, apartments, conference facilities, spiritual and moral rehabilitation centres, hotel industry, restaurant, café, tavern, refreshment room and lodging house keepers, licensed victuals, importers and manufacturers of aerated, mineral and artificial water and other drinks, purveyors, caterers for public amusement generally.

To hold, receive, purchase or otherwise acquire or have transferred to it and undertake all or any part of the functions, business, property, and liabilities of any individual person or company or any other person recognized in law, in trust of that person or company or person recognized in law.
