Mnamo tarehe 17/07/2017 Kumb.TICC/B.10/17/132 na 17/04/2020 nilipokea barua yenye Kumb.Na.TIC/B.10/17/KIG/68 ambayo ilinieleza kuwa Mkurugenzi mtendaji hakuridia maombi yangu ya kumilikishwa ardhi iliopo lugufu wilaya ya uvinza-Kigoma.

Maombi yangu yalikataliwa kwasababu eneo limetengwa kwa ajili ya uwekezaji mkubwa wa kilimo cha michikichi na sio uwekezaji mdogo. Lakini kwenye barua yangu ya maombi nilieleza kua nitafanya uwekezaji wa michikichi (large scale) kama ilivyo kusudiwa. Chakusikitisha barua yangu yakukataliwa ombi langu inasema niliadhimia uwekezaji mdogo kwenye kilimo cha ufuta.


Kampuni yangu **Kandeke Foundation** now (Sky Mwamoto Ltd) haijasajiliwa na kituo cha uwekezaji (TIC) k na kuhusu kusajiliwa ningeomba kupewa utaratibu wakujisajili ili niweze kuendelea na uwekezaji.

Pia ningeomba nikumbushe wizara ya uwekezaji pamoja na kituo cha uwekezaji (TIC) kua mnamo tarehe 21/09/2017 nilipewa barua kutoka ofisi ya tawala za mikoa na serekali za mitaa (TAMISEMI) yenye Kumb.Na GB199/203/01/29 ilio elekeza kua Kandeke Foundation inaruhusiwa kuendeleza shamba hilo. Kwa uthibitisho zaidi naambatanisha barua hizo. Kwamasikitiko makubwa niliambiwa niondoke na kwamba sipo kihalali na tayali zaidi ya million miambili (200,000,000 tshs) zimewekezwa pale kwa kuandaa shamba na vifaa kwa ajili ya kuendeleza shamba hilo.

Kwa kumaliza nigeomba wizara husika pamoja na uongozi wa kituo cha uwekezaji (TIC) wanimilikishe eneo hilo ili niweze kuendelea na uwekezaji.

Nimepokea barua ya malalamiko (isiyokuwa na Kumb. Na. wala tarehe) kutoka **KANDEKE FOUNDATION** ikilalamikia hatua ya Halmashauri ya Uvinza kuwafukuza katika shamba lililopo eneo la Lugufu - Uvinza kwa uonevu (*Kiambatisho*).

Aidha, baada ya kuisoma barua hiyo ya malalamiko na kuongea na wewe Mkurugenzi, nimegundua kuwa halmashauri haikutenda haki katika hatua yake hiyo ya kuwafukuza *Kandeki Foundation* kwa sababu zifuatazo:-

- 1) Eneo linalolalamikiwa linamilikiwa na NGO ambayo tangu imilikishwe haijaendeleza shamba hilo. Aidha, halmashauri ina mpango wa kuwanyang'anya wenye NGO hiyo ili kuwapa wawekezaji wengine.
- 2) Kuna baadhi ya wawekezaji bado wapo wanafanya uwekezaji wa kilimo katika eneo hilo lakini hawajafukuzwa.
- 3) Halmashauri ndiyo iliyowapa *Kandeki foundation* eneo hilo la shamba.

Kwa kuwa eneo hilo linamilikiwa kihalali na NGO, wote waliopo eneo hilo walistahili wasiruhusiwe kulima katika eneo hilo. Hata hivyo kwa kuwa wenye shamba hilo wamelitelekeza, mpango wa halmashauri ni kuwanyang'anya, waacheni wawekezaji waliopo waendeleo kulima lakini wasijenge majengo ya kudumu wala kupanda mazao ya muda mrefu kama kahawa, miti n.k.
