MEMORANDUM OF ASSOCIATION

OF

AL DAARA PETROCHEMICAL COMPANY (T) LIMITED

1. The name of the Company is "*AL- DAARA PETROCHEMICAL COMPANY (T) LIMITED*"
2. The registered office of the Company will be situated in the Mainland of the United Republic of Tanzania.
3. The objects for which the Company is formed are:-
 - (a) 9609 - Other service activities.
 - (b) 96 - Other personal service activities
 - (c) 960 - Other personal Service Activities
 - (d) 9609 - Other personal Service Activities

And it is hereby declared that the word 'company' in this clause, except where used in reference to this Company, shall be deemed to include any partnership or other body of persons, whether incorporated or not incorporated, and whether domiciled in Tanzania or elsewhere, and that the objects specified in the different paragraphs of this clause shall not, except where the context expressly so requires, be in anywise limited or restricted by reference to or inference from the terms of any other paragraph or the name of the Company, but may be carried out in as full and ample a manner and shall be construed in as wide a sense as if each of the said paragraphs defined the objects of a separate, distinct and independent company.

4. The liability of the Members is limited.
5. The share capital of the Company is Tanzania Shillings Ten Million (10,000,000/-) divided into One Hundred (100) ordinary shares of Tsh. (100,000/-) each, and the Company shall have the power to divide the original or any increased capital into several classes, and to attach thereto any preferential, deferred, qualified or other special rights, privileges, restrictions or conditions.
