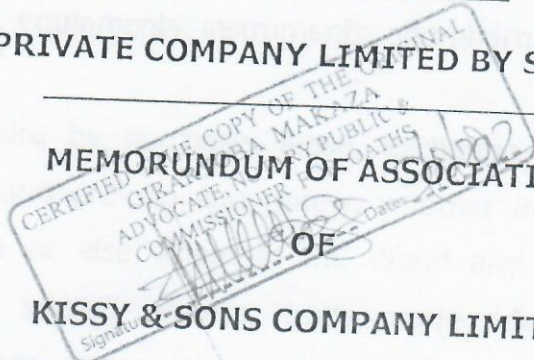

1. The Company's name "KISSY & SONS COMPANY LIMITED"
2. The Company's registered office is to be situated in Tanzania.
3. The Company's objective are:
 - a) To carry on the activities and business of a general commercial company, a general investment company and general supplies company.
 - b) To carry on the business and activities of importing and distribution, importing and supplying, importing and selling of all spare parts ranging from industrial spare parts, mining spare parts, agricultural machines spare parts, lubricants, establishing garages, workshops, shops.
 - c) To carry on business and activities of establishing petrol station services, car wash services, car services and washing blocks, vehicle parking services and wheel balance services, min and super markets, hotels and catering services, gym and night clubs, clearing and forwarding activities and transportations activities.
 - d) To engage and carry on the activities of construction and building ranging from construction and building of dams, storey, houses, bridges, and to carry on the activities of investing in real estates and

building of apartments of different kinds and to carry on the activities of importing and distributing agricultural inputs such as agro-chemicals, agro-seeds, agro-machinery, veterinary medicines, drugs, utensils, equipments, instruments, and pharmaceutical products.

e) To acquire by purchase, lease, exchange, hire, or otherwise and protect and prolong and renew, whether in the United Republic of Tanzania or else where in the World any patents, patents rights, licenses, secret, process, trade marks, designs, protections, and concessions or any other intellectual property rights and to disclaim, alter, modify, use and turn to account and to manufacture under or grant license or privileges in respect thereof.

f) To conduct research, provide consultation, advice; represent business, provision of professional services and expertise in business related matters, and to sell or otherwise dispose of the whole or any part of the business or property of the company for such consideration as the company may think fit.

g) To acquire or undertake the whole or any part of the business, goodwill, and assets of any person, firm or company carrying on or proposing to carry on any of the business which the company is authorized to carry on and undertake all or any of the liabilities of such a person, firm or company as part of the consideration for such acquisitions, or to acquire an interest in, amalgamate with or enter into partnership or into any arrangement for sharing profits, or corporation, or otherwise assisting any such person, firm of a company, or of subsidizing or otherwise assisting any such person, firm or company, and to give or accept, by way of consideration for any of the Acts or things aforesaid or property acquired, any shares, debentures stock or securities that may be agreed upon, and to hold and retain, or sell,

mortgage and deal with any shares, debentures, stock or securities so received.

- h) To borrow and raise money in any manner and to secure the repayment of any money borrowed, raised or owing by mortgage charge, standard security, lien or other security upon the whole or any part of the company's property or assets (whether present or future) including its uncalled capital and also by a similar mortgage, charge standard security, lien or security to secure and guarantee the performance by the company of any obligation or liability it may undertake or which may become binding on it.
- i) To draw, make, accept, endorse, discount, negotiate, execute, and issue Chequies, bills of exchange, promissory notes, warrants, debentures, and other negotiable or transferable instruments.
- j) To oppose any proceedings or applications which may seem calculated directly or indirectly to prejudice the company's interests.
- k) To acquire by subscription or otherwise hold, sell, deal with and dispose of, place and underwrite shares stocks, debentures, debenture stocks, or any other securities issued or guaranteed by any company constituted or carrying on business in any part of the world, and any such securities of any such company as aforesaid.
- l) To control, manage finance subsidies, coordinate of otherwise assist any company or companies in which the company has a direct or indirect financial interest.
- m) To promote any other company for the purpose of acquiring the whole or any part of it if it appears likely to assist or benefit the company or

to enhance the value of any property of business of the company, and to place or guarantee the placing of, underwrite subscribe for, or otherwise acquire all or any part of the shares or securities of any such company as aforesaid.

- n) To sell or dispose of the whole or any part of the business or property of the company for such consideration as the company may think fit.
- o) To act as agent or brokers and as trustees for any person, firm, or company and undertake and perform sub-contracts.
- p) To remunerate any person, firm or company rendering services to the company either by cash payment or otherwise
- q) To distribute among the members of the company in kind any property of the company properly distributable amongst the members.
- r) To purchase, take on lease or otherwise acquire and to rebuild, alter, reconstruct any land or property of any tenure for the purpose the manufacture, sale or warehousing of the products aforesaid.
- s) To pay all or any expenses incurred in connection with the formation, promotion and incorporation of the company or to contract with any person, firm or company to pay the same.
- t) To give or award pensions, annuities, gratuities and superannuation of other allowances or benefits or charitable and generally to provide advantages, facilities and services for any persons who are or have been Directors or employees of the company, or the holding of the company or the company or a fellow subsidiary of the company or the predecessors in business of the company or of any such subsidiary,

holding of fellow subsidiary company and to the wives, widows, children and other relatives and dependants of such person.

- u) To enter into any arrangement with any Governments or authorities supreme, municipal, local or otherwise any of them and to obtain from any such Governments, Authority, persons or company any rights, privileges, characters, contracts, licenses and concessions which the company may think it desirable to obtain and to carry out, exercise and comply therewith.
- v) To procure the Company to be registered or recognized in any part of the world and to discover and develop, research, manufacture, and process and sell of any medicinal products in any material whatsoever which shall be discovered thereto.
- w) To do all or any of the things authorized in any part of the world and either as principals, agents, contractors, or otherwise, and by or through agents, brokers, subcontractors, or otherwise and either alone or in conjunction with others.
- x) To distribute among the members in specie any property of the company or any proceeds of sale or disposal of any property of the company but so that no distribution amounting to a reduction of capital shall be made except with the sanction (if any for the time being required by law).
- y) To support and subscribe to any charitable or public objects and institution, society or club which may be for the benefit of the company or its employees or may be connected with any town or place where the company carried on business.

z) To do all such other things as may be deemed incidental or conducive to the attachment of the company's objectives or of any powers given to it by the Companies Act, Act No. 12 of 2002 of the United Republic of Tanzania.

AND SO THAT:

- (i) None of the provisions set forth in any sub-clause of this clause shall be restrictive construed but the widest interpretation shall be given to each such provision, and none of such provisions shall, except where the context expressly so requires, be in any way limited or restrictive by reference from any other provisions set forth in such sub clause, or by reference to inference form the terms of any other sub clause of this clause, or by reference to or inference form the name of the company.
- (ii) The Word "Company" in this Clause except where used in reference to the Company, shall be deemed to include any partnership or other body of persons, whether incorporated or unincorporated and whether domiciled in the United Republic of Tanzania or elsewhere.
- (iii) In this Clause the expression "The Act" means the Companies Act, Act No. 12 of 2002, but so that any reference in this clause to any provision of the act shall be deemed to include a reference to any statutory modification or re-enactment of the provision for the time being in force.

4. The Liability of the Members is Limited.

5. The Company's share capital is **TSHS. 100,000,000/=** divided into **100,000 Shares** of TSHS. **1000/=** each, with the power of increase or to divide the shares in the capital for the time being, into different classes having such rights, privileges and advantages as to voting and otherwise, as the Articles of Association may from time to time prescribe.

We, the persons whose names and addresses are subscribed, desire to be formed into a company, in pursuance of this memorandum of association, and we respectively agree to take the number of shares in capital of the company set opposite our respective names.
