Reference is made to your letter dated 20th September, 2021 as supported by a letter from Tanzania Investment Centre with Ref. No. **TICC/043318/20** of **24th June, 2021** on the above captioned subject.

We hereby confirm and approve **one-page** list of items herewith attached as deemed capital goods for establishment and facilitation of your project with the certificate of incentives mentioned above. Please note that the deleted items are not eligible for exemption.

The approved deemed capital goods will be exempted from Import Duty to the tune of 75% of the Import Duty Payable.
