1.0 BACKGROUND

2.0 Methodology

The following methodology were used to conduct the PVV

- Review the submitted request documents so as to understand the proposed project.
- Interview one Director, Mr. Victor Godfrey Wambura to get more information on the proposed project.
- Physical site visitation to verify the location and progress of the project

3.0 Interviews, Observations and Findings

On 05th October, 2022, the PVV team visited the company and had a consultative conversation with Mr. Victor Godfrey Wambura - Director of the company, to acquire important information on the project. The following are the key issues observed.

- The promoter has the skills on Three-wheelers rick-shaw and car assembling business, which will create a room for knowledge transfer.
- Mission of the company is to develop a highly successful Three-wheelers rick-shaw assembling facility and business that is known to assemble durable and affordable automobiles for both the rich and the general populace

- Promoters have committed to expand the project by importing a modern automobile assembling machineries.
- They proposed to relocate the project to Coast Region after few year of operation as the expansion plan. They are currently looking for the favorable area for the project.

3.1 Physical Project progress

- There is a building for the three wheel assembling activities (See appendix no.1)
- The location of the office is at Ukonga, Mazizini, Ilala District, Dar es Salaam, approximated to 1 meters from the main road.
- There is neither ongoing operation nor employees seen in the building.

4.0 Recommendations

Based on the findings observed, we wish to recommend as follows:

Our Government prioritizes the automotive segment as a vital revenue generator and is boosting flow of FDIs in automotive industry, establishment of this three wheel assembling facilities is a milestone for our country. VICHWA BRANDS (T) CORPORATION LTD, shown efforts in implementing the project, as they are currently looking for the new area in Coast region for relocating the project as an expansion plan. We recommend TIC to grant the certificate of Incentives for smooth implementation of this project.
