RE: DUTY AND VAT EXEMPTION ON CAPITAL GOODS VIDE CERTIFICATE OF INCENTIVES NO. 071030 OF 5th DECEMBER 2014 AND TIN NO.121-531-526

Reference is made to your letter dated 17th September 2014 as supported by the letter ref. TICC/PP.10/071030/6 of 25th September 2014 from Tanzania Investment Centre regarding the captioned subject.

We hereby confirm and approve items in a single-page –list here with attached as capital/deemed goods for establishment and facilitation of the project located at Plot No.17 Industrial Area, Pugu Road Ilala-Dar-es-salaam, With the Certificate of Incentives mentioned above. However, age of the approved motor vehicles at the time of importation should be within the limit specified in the law.

The approved deemed capital items will be exempted from the import duty to the tune of 75% of the amount of import duty payable on the goods and VAT relief to the tune of 45% of the amount payable. Please complete VAT form 224 and submit the same to the Commissioner for Customs and Excise.
