The company has a project for cargo transportation; this project is registered by the Tanzania Investment Center (TIC) with Certificate of Incentives Number 022252 issued on 14<sup>th</sup> February 2019.

### 3. PROJECT VERIFICATION VISIT (PVV)

#### 3.1 PVV initiation

According to the granted COI, the company aimed to establish a project for cargo transportation with a project implementation plan starting from February 2019 to January 2022 however, the company submitted to TIC a letter notifying the

center that the company wishes to extend the implementation period because they did not enjoy exemption in previous three years due to COVID 19.

### **3.2 PVV Conduction**

On 21<sup>st</sup> March 2022 team of three officers from TIC was appointed to conduct PVV at CJ SC LOGISTICS (T) LIMITED located at MNF Square Plot No. 2217/1/168 Block A Sokoine Drive and Mainfiled Ilala. The team comprised the followings officers:

- (i) Privata Simon
- (ii) Steven Mkama
- (iii) Navone Kisaka

The company was represented by Mr. Salum Malimba, Business Development Manager.

#### **3.2.1 Project Visit Objective**

The main purpose of the PVV was to establish grounds which could enable TIC management to make informed decision whether the company qualifies for 1 year's extension of COI's implementation period or not.

#### **3.2.2 Project Visit Specific Objectives**

Specifically, the PVV visit aimed to:-

- i. Interview and gather information from the applicant regarding the COI extension application
- ii. Take copies of relevant document /photos as evidence for the application
- iii. Physically visit the project site and verify its status of completion

### 3.3 Findings

- The team managed to visit the mentioned location of the project as scheduled and established the following facts:-
  1. The office has signs for a different company which they claimed to be their sister company
  2. They don't have a car yard, they claim that they normally rent space at Mbagala in case they need to park their cars

### 3.4 Challenges

They faced the following challenges during their project implementation.

1. **COVID-19 Pandemic:** Travel restrictions and lockdowns imposed globally caused price fluctuation which resulted in significant adverse impacts on the business cycles. E.g. The price of shipping containers from China rose 3-folds and some industries stopped production of relevant raw materials and machinery for the project, especially in Tanga.

### 3.5 Future Plans


It was established that, they have the following plans;
