

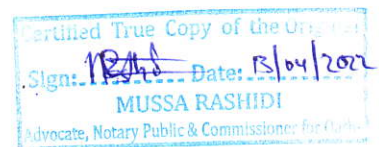

MEMORANDUM OF ASSOCIATION
OF
QUICK PROPERTIES COMPANY LIMITED

1. The name of the Company is: - **QUICK PROPERTIES COMPANY LIMITED**
2. The registered office of the Company will be situated in the United Republic of Tanzania.
3. The objects for which the company is established are:-
 - (a) To acquire by purchase, exchange, or otherwise certain lands, houses, buildings or any other lands, tenements and premises of any tenure, whether subject or not to any charges or encumbrances and to hold or sell, let, alienate, mortgage charge or otherwise deal with all or any such lands, tenements or premises.
 - (b) To let on lease any such premises or part thereof and to provide such facilities for the occupiers or tenants thereof as are commonly provided in residential flats, business offices or hotels.
 - (c) To lend or advance money to builders and other persons on securities of all descriptions whether real or personal and to grant loans upon mortgage of any lands, buildings and premises of whatever tenure for improvement thereof or otherwise.
 - (d) To carry on the business of builders and contractors for construction or demolition work of any kind.
 - (e) To buy, sell or otherwise deal in estate management or acquire lands, houses, offices, workshops, buildings and premises for the purpose of that business;
 - (f) To purchase or otherwise acquire and to manufacture and deal in bricks, stone and other building materials of any kind, and all implements, machinery, vehicles, scaffolding and other equipment and articles used by builders and contractors;

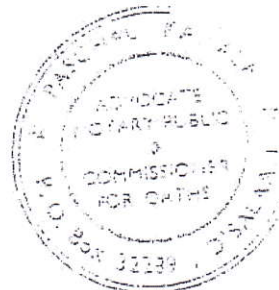
