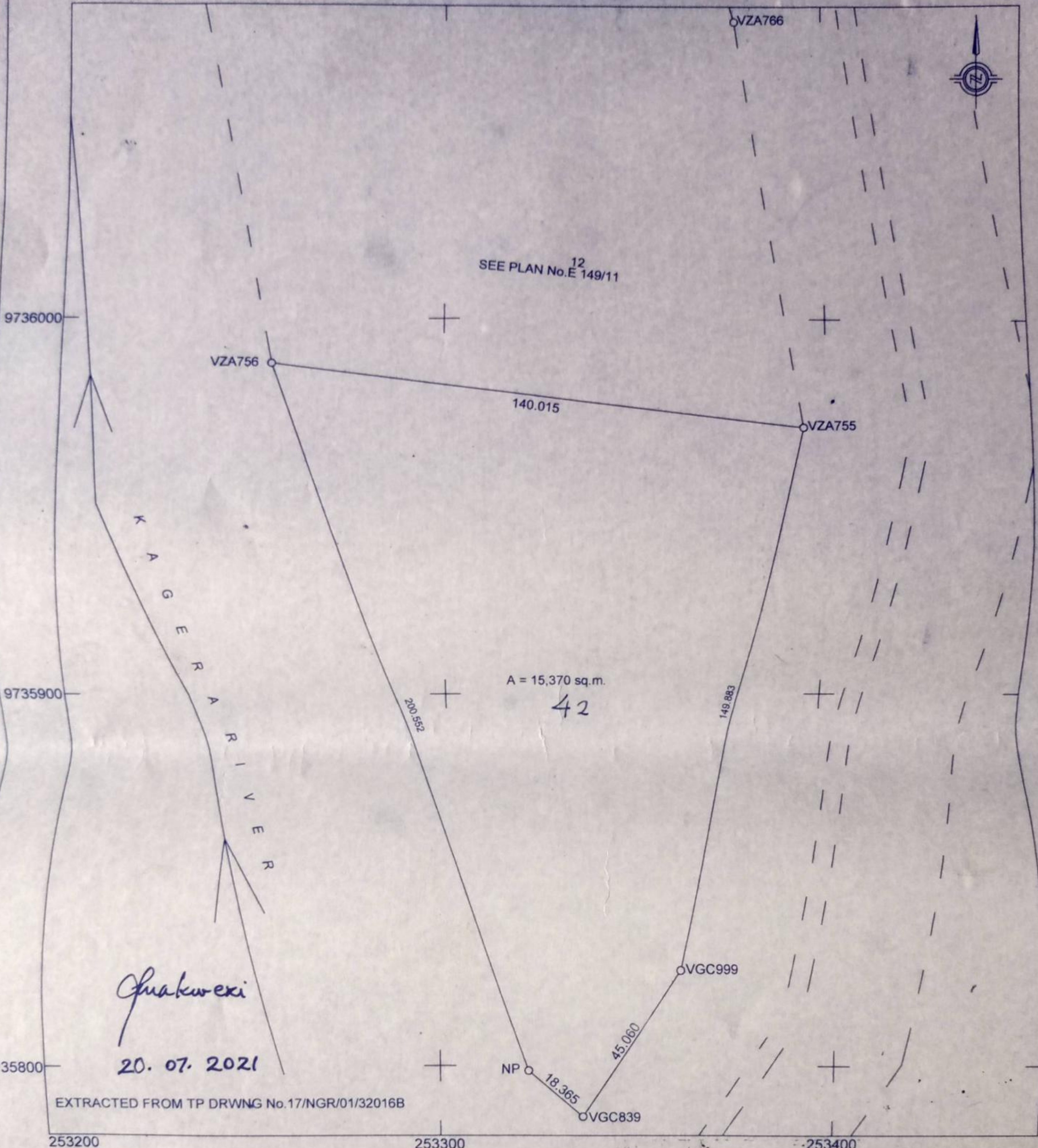

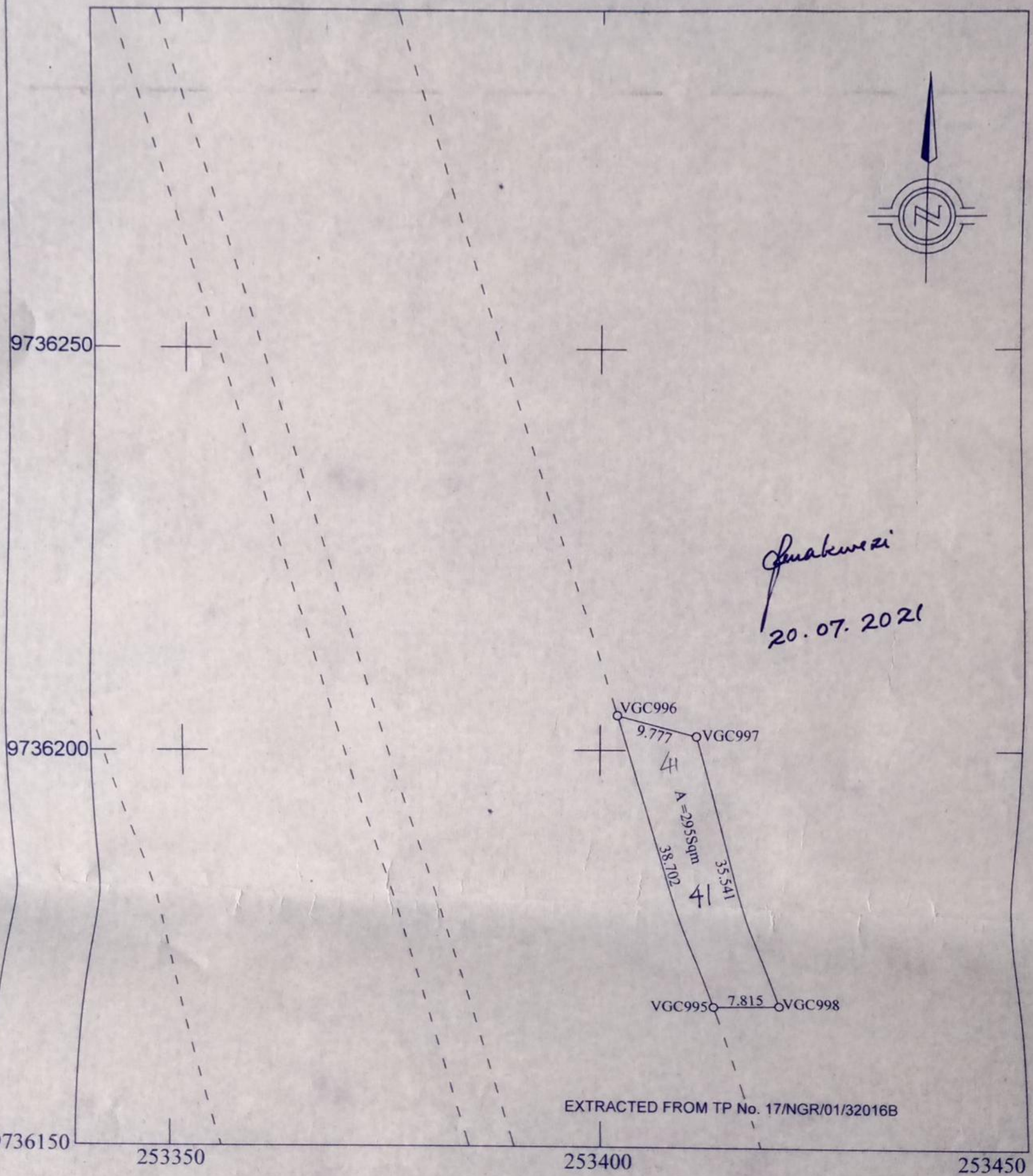

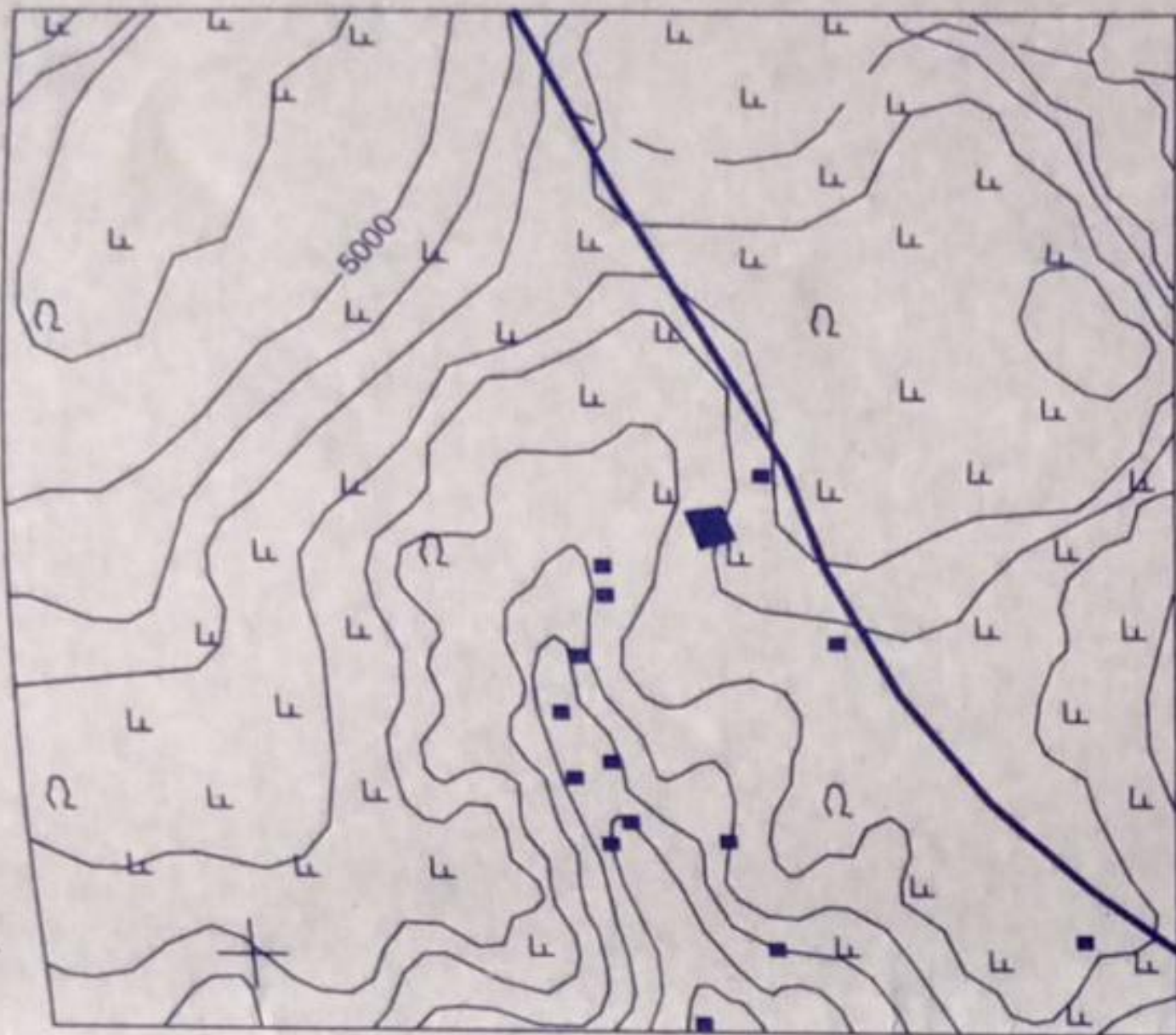
SURVEY OF PLOT NO 1 BLOCK A AT KAHAZA RUSUMO
