**6. Problems and Solution**

We have not managed to start the project despite having capital sufficient to commence business DUE TO LACK OF WATER SUPPLY to enable production. Initially we tried to install water from MWAUWASA but owing to the factory being located in Misungwi, the water meter was installed away from the factory which made monthly water bills high and unaffordable as the neighboring residents were diverting water pipes to their use at the factory expenses. As a result we opted to stop the services. We tried to drill water which costed the company about Tshs 70,000,000/= but was not successful.

We have reported all this to the Government Authorities both Misungwi District and Mwanza Region in no vain

7. **Future Plans**

We already have an idle running capital of USD 400,000/=. IN CASE WATER SUPPLY IS FACILITATED we are ready to commence production with immediate effect. However this time we plan to change the project from MEAT PROCESSING AND EXPORT to TISSUE PAPERS

8. **Recommendations and any other comments:** We recommend that the government intervene and help us get water supply as soon as possible in order to start production as our investment on land and buildings is yielding no return so far
