MEMORANDUM OF ASSOCIATION

OF

JFJ TARGET INTERNATIONAL COMPANY LIMITED

1. The name of the company is JFJ TARGET INTERNATIONAL COMPANY LIMITED.
2. The registered office of the company will be situated in Tanzania.
3. The objects for which the company is established are as follows;
 - (a) Fishing on a commercial basis in inland waters, taking of freshwater crustaceans and mollusks, taking of freshwater aquatic animals and gathering freshwater materials;
 - (b) Preparation and preservation of fish, crustaceans and mollusks, freezing, deep freezing, drying, smoking, salting, immersing in brine, canning etc, production of fish, crustacean and mollusc products; cooked fish, fish fillets, roes, caviar, caviar substitutes, production of fish meals for human consumption or animal feed and production of meals and soluble from fish and other aquatic animals unfit for human consumption;
 - (c) To conduct mixed farming and livestock keeping and conducting food processing, packaging and marketing of agricultural produces such as maize flower, rice, sorghum, fruit juice, soya, meal mixing and lishe flour etc.
 - (d) To conduct mixed farming by engaging on activities of agriculture, forestry and fishing;
 - (e) To carry on manufacturing of finished goods from agricultural produces;
 - (f) To deal with Electricity, gas, steam and air conditioning supply
 - (g) To conduct wholesale and retail trade; repair of motor vehicles and motorcycles
 - (h) To carry on transportation and storage activities;

4. The Liability of the members is limited by shares.
5. The share capital of the company is Tanzania Shillings One Hundred Millions (100,000,000/=), divided into One hundred (100) ordinary shares of Tanzania shillings One Million (1,000,000/=) each with which the company shall have power to increase, reduce or divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such preferential, deferred or in accordance with the Articles of Association of the company.

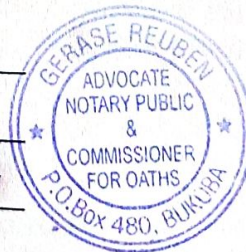

ARTICLES OF ASSOCIATION

OF

Interpretation

1. In these articles.

"The Act" means the Companies Act;

"Articles" means the Articles of Association of JFJ TARGET INTERNATIONAL COMPANY LIMITED

"The Board", "Board" or the "Board of Director" means the overall governing body of JFJ TARGET INTERNATIONAL COMPANY LIMITED established under this article.

Board of Directors
