**Re: ALLOCATION OF HUNTING BLOCK FOR 2023- 2032 HUNTING
TENURE**

Pursuant to section 38(6) of the Wildlife Conservation Act Cap. 283 R.E 2022 read together with regulation 12(3) and 12(A)(1) of the Wildlife Conservation (Tourist Hunting) Regulations, 2015 with its amendments, please be informed that I have allocated your company i.e Wembere Hunting Safaris Ltd the Kilombero Ruhudji/Ifinga (East) hunting block that you won during the 6th electronic auctioning of hunting blocks which took place from 12th to 18th January, 2022. In addition to conditions stipulated in the certificate of allocation, this allocation is granted under the following conditions: -

- a. The tenure of ownership of the allocated hunting block shall commence on 1st January, 2023 and shall end on 31st December, 2032, subject to review of the performance of your hunting company;
 - b. Pay in time all fees and charges related to tourist hunting activities as prescribed in the law.
 - c. The winning bid during the electronic auction shall be the **annual block fee** for the block won, which in this case is **US\$ 81,000** for the entire tenure of such block;
 - d. Upon termination or cancellation of the allocation of hunting block, all immovable assets in such block shall be vested in the Government.
2. You are required to acknowledge allocation of the said hunting block within 21 days from the date of this letter, indicating your commitment to comply to the Wildlife Conservation Act Cap. 283 R.E 2022 and its subsequent regulations governing tourist hunting in Tanzania. Enclosed with this letter please find the Hunting Block Allocation Certificate and a Map of the Kilombero Ruhudji/Ifinga (East) Hunting Block.
