You will recall that in our report, we mentioned about three main reasons for such a delay as follows:-

- (a) Almost 90% of the company Shareholders are Australian citizens and are the one who have been financing the project.

During the years 2020 up to mid 2022 Australia was amongst the countries in the world which were highly affected by COVID 19 pandemic and the country was 100% locked down for more than twelve months and almost all businesses were completely closed including Bank operations.

This problem does not need documentary evidence as it can be verified by anybody through available Australian Government information.

However, we attach herewith two Passport copies of Directors which shows their immigration status from Australia to Tanzania.

- (b) The second problem is that for such a delay, the initial establishment costs of the project have been very high than expected or budgeted before.
- (c) Finally the war in Russia and Ukraine highly affected the prices of goods and also there has been a difficulty in shipment of goods from one continent to another.

Therefore, these have been the main reasons which made it difficult or impossible to utilize the granted final extension for the completion of the project.

We positively look forward for your consideration and approval to enable the project establishment objectives be realized.
