### **ACCUPATIONAL HEALTH AND SAFETY POLICY**

#### **Introduction**

A health and safety policy sets out how health and safety is managed within our company and demonstrates a commitment to the health and safety our staff.

We have a duty of care to protect our employees from harm arising from works activities. The Health and Safety at Work etc. Act 1974 states that all organizations should have a health and safety policy, and where they employ five or more people this must be a written policy.

This policy should cover all aspects of the company and be relevant to our staff. It is only required to address health and safety matters relating to our staff, however, employers also have a duty to protect others from risks arising out of their works activities and so it is best practice to consider the safety of people whose health and safety might be affected by the company.

It is important that all our staff are aware of, and understand the health and safety policy and have access to a copy of it. This means that it should be clear and easy to understand.

In the construction industry it is common to require that companies submit their health and safety policy as part of the tender documentation when bidding for works.

#### **Our safety policy structure**

A typical structure for a health and safety policy including:

- A statement setting out general policy on health and safety which details the commitment to effective management of health and safety and the overall aims.
- A responsibilities section which explains who is responsible for specific actions.
- An arrangements section which describes the methods that will be adopted to achieve the commitments made in the statement section. Information should also be included about how risks and hazards in the workplace will be eliminated or reduced. According to the Health and Safety Executive, a hazard is something that could cause harm to people such as electricity, chemicals and working at height. A risk is the chance (however large or small) that a hazard could cause harm.

It is vital that the policy is monitored and evaluated to ensure that it is still effective. Monitoring can be undertaken in many ways, for example by undertaking spot checks or safety inspections using checklists. In a more formal situation, audits and the review of management reports and accident investigations can be undertaken.

Also our company is registered with OSHA for registration No. DSM/0818 We care health and safety of our staff.

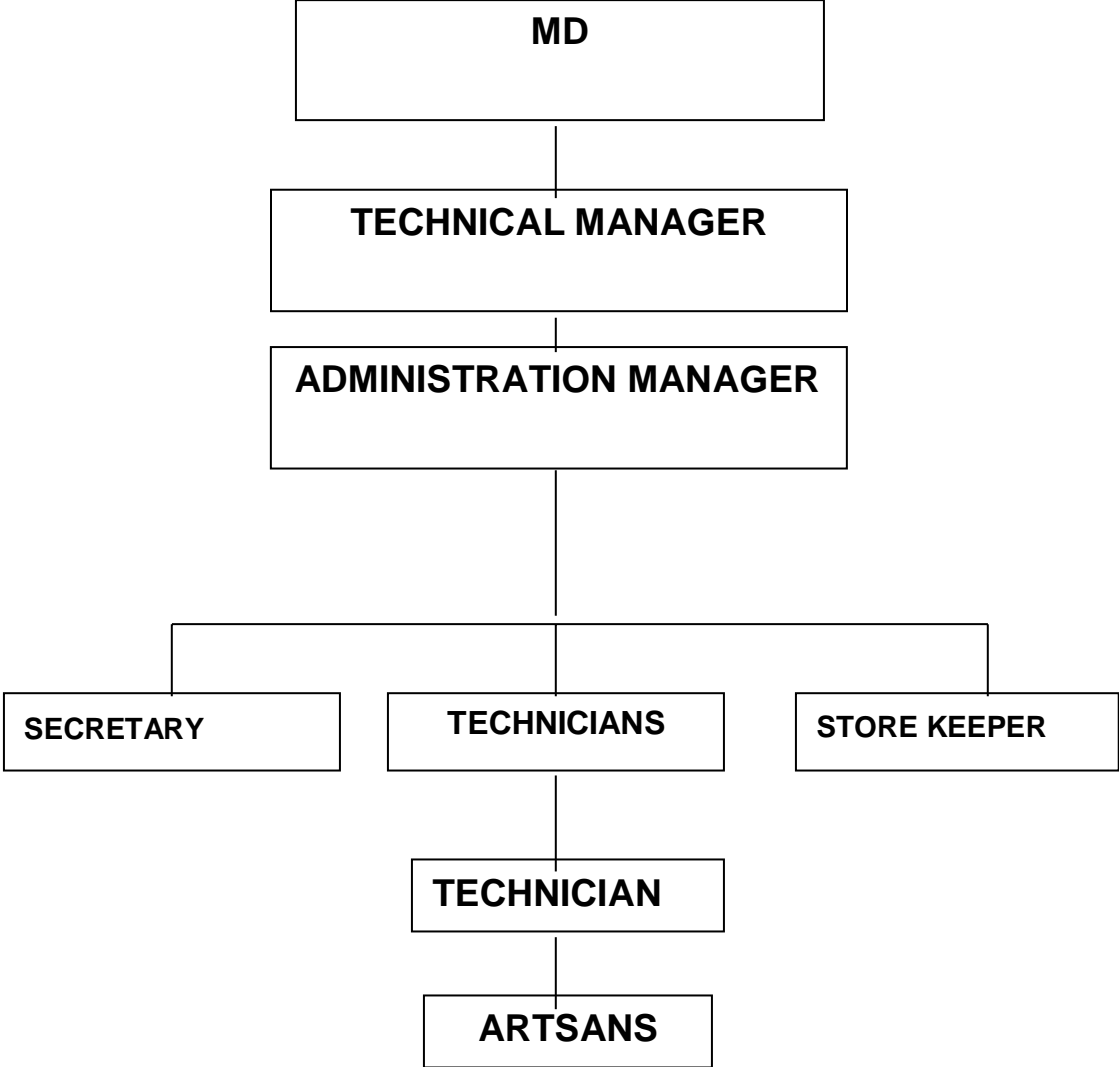

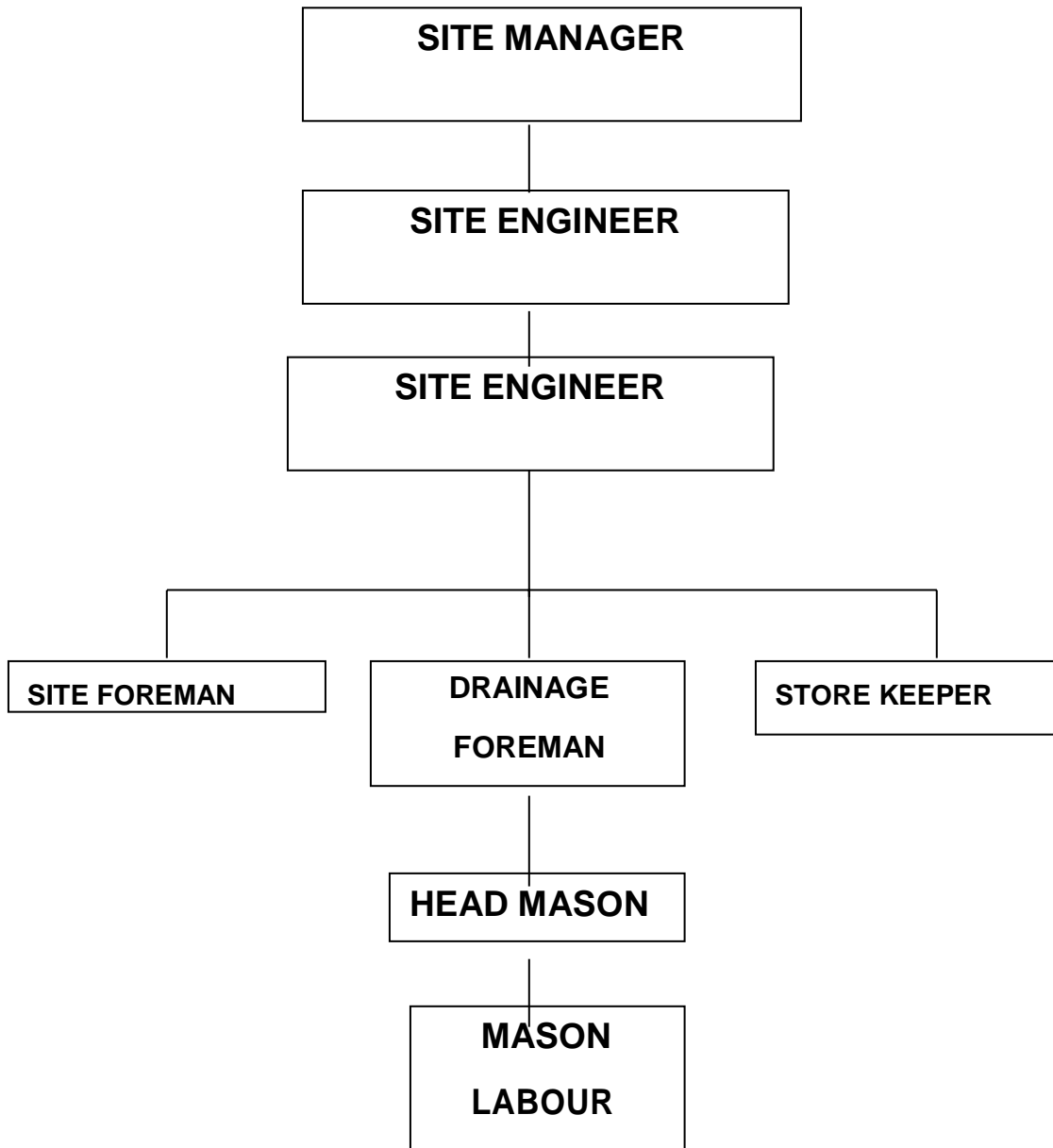
