MEMORANDUM OF ASSOCIATION

OF

ASAS TRANSPORTERS COMPANY LIMITED

1. The name of the Company is "ASAS TRANSPORTERS COMPANY LIMITED."

2. The Registered Office of the Company will be situated in the Mainland Tanzania.

objects for which the Company is established are:-

- a) To carry on all or any of the business of transport, clearing and forwarding agents, warehousemen, store keepers, insurance agents or brokers, cartage and haulage contractors, garage proprietors, owners and charterers of road vehicles, aircraft and ships, tugs, barges and boats of every description, lightermen and carriers of goods and passengers by road, rail, water or air, carmen, cartage contractors and agents, transport and commission agents, stevedores, wharfingers, cargo superintendents, packers, haulers, travel agents in all their branches, wook-workers and cabinetmakers, glass, pottery, china and earthen ware manufacturers and dealers, metal and alloymakers, refiners and workers, engineers of all descriptions, storage proprietors, electricians, fuel merchants, grocers, provision dealers and general merchants.
- b) To purchase or otherwise acquire real and personal, estate of any description, to develop the resources of the same by building or otherwise, and to sell lease, mortgage, exchange or otherwise deal with all or any of the real or personal property of the Company.
- c) To purchase or by any means acquire any freehold, leasehold, or other property for any estate or interest whatsoever and any rights privileges or easements over, or in respect of any property or any buildings, factories, mill, workes, wharves, roads, railway, tramways, machinery, engines, rolling stock, plant, barges, vessels or things and real or personal property or rights whatsoever which may be conveniently used with or may enhance the value of any other property of the Company.
- d) To carry on the profession and/or business of and/or act as Industrial Consultants in Tanzania and/or elsewhere and to carry out and do all such acts and things as are normally and properly and/or may be usefully carried out and done in connection with the said profession and/or business.
- e) To arrange for, secure and participate in the investigation, formulation and carrying out of projects for the development of industry, tourism and/or for the production of foodstuffs and raw materials in Tanzania.
- f) To act as Managers of or Managing Agents or Consultants to any Company or association in Tanzania or elsewhere or of any undertaking works project and/or enterprise of any such Company or association in Tanzania or elsewhere
