2. The registered office of the Company will be situated in Tanzania.
3. The objects for which the Company is established are: -
  - 3.1 Import and sale of marine vessels and accessories.
  - 3.2 Manufacture and sale of marine vessels
  - 3.3 Import and sale of fishing equipment and material
  - 3.4 Fishing activities and fish processing
  - 3.5 Import and sale of pest control products
  - 3.6 Import and sale of agriculture machinery and equipment
  - 3.7 Import and sale of seeds
  - 3.8 Import and sale of fertilizer
  - 3.9 Import and sale of ICT equipment
  - 3.10 Import and sale of security machine and tracking system products
  - 3.11 Installation, maintenance and service of security machines, tracking system, and ICT equipment.
4. The liability of the members is **Limited**.
5. The share Capital of the Company is **Tanzanian Shillings ONE BILLION (T. Shs 1,000,000,000/=)** Divided into ONE HUNDRED (100) shares of **Tanzanian Shillings TEN MILLION (T.
