

MKATABA WA MAUZIANO YA SHAMBA

LAND PROPERTY SALE AGREEMENT

MKATABA HUU umefanyika leo tarehe 17th mwezi wa 02 mwaka 2022

THIS AGREEMENT was made today on 17th of 02 in year of 2022

BAINA YA (BETWEEN)

JUMA MOHAMED SAID wa S.L.P, Mbande, Dar es Salaam (kwa madhumini ya mkataba huu ataitwa *Muuzaji*) kwa upande mmoja. JUMA MOHAMED NGUTUBU of P.O.Box, Mbande, Dar es Salaam (for the purpose of this contract will be called "THE SELLER") on the one hand

NA (AND)

ANRIC GAS TECHNOLOGY COMPANY LTD wa S.L.P 77819, Tazara, Temeke, Dar es Salaam (kwa madhumuni ya mkataba huu ataitwa "*MUUZAJI*") kwa upande mwingine wa mkataba.

(ANRIC GAS TECHNOLOGY COMPANY LTD P.O.Box 77819, Tazara, Temeke, Dar es Salaam for the purpose of this contract will be called "THE BUYER") on the other side of the contract.

KWAKUWA, marehemu MOHAMED SAID NGUTUBU ni mmiliki halali wa shamba ambalo halijapimwa (*unsurveyed*) lenye ukubwa wa Ekari 1.90 (mita za mraba 19,000), lililopo KIJJI CHA MWANAMBAYA, WILAYA YA MKURANGA, MKOA WA PWANI (kwa madhumini ya mkataba huu itaitwa "SHAMBA AMBALO HALIJAPIMWA")

WHEREAS, the deceased MOHAMED SAID NGUTUBU is the rightful owner of the unsurveyed land property with 1.90 acres farm (19,000 square meters), located in MWANAMBAYA VILLAGE, MKURANGA



DISTRICT, COASTAL REGION (for the purpose of this contract will be called "THE UNSURVEYED LAND PROPERTY")

NA KWAKUWA, MUUZAJI (JUMA MOHAMED SAID) ni msimamizi wa mirathi ya marehemu MOHAMED SAID NGUTUBU ambae amechaguliwa na mahakama na kupewa ridhaa kutoka kwa warithi wote kusimamia mali za marehemu ikiwemo shamba lililopo **KIJI CHA MWANAMBAYA, WILAYA YA MKURANGA, MKOA WA PWANI.**

AND WHEREAS, THE SELLER (JUMA MOHAMED SAID) is the administrator who appointed by the court of law and with consent of heirs to administer the estate of late MOHAMED SAID NGUTUBU, which include the unsurveyed land property with 1.90 acres (19,000 square meters) located in MWANAMBAYA VILLAGE, MKURANGA DISTRICT, COASTAL REGION

NA KWAKUWA MUUZAJI kwa hiari yake na hiari za warithi wa mali za marehemu MOHAMED SAID NGUTUBU amekubali kumuuzia MNUNUZI SHAMBA AMBALO HALJAPIMWA.

AND WHEREAS THE SELLER with his own consent and consent of all beneficiaries of the estate of late MOHAMED SAID NGUTUBU has agreed to sell the UNSURVEYED LAND PROPERTY to the BUYER.

NA KWAKUWA MNUNUZI kwa kupitia maafikiano ya Pamoja ya kampuni wamekubali kulinunua SHAMBA AMBALO HALJAPIMWA kutoka kwa MUUZAJI.

MNUNUZI na MUUZAJI wote kwa pamoja wamekubaliana makubaliano YASOMEKE KAMA IFUATAVYO:

AND WHEREAS, the BUYER through a board resolution of the company has agreed to purchase the UNSURVEYED LAND PROPERTY from the SELLER.

BUYER and SELLER both agree that the agreement should be read AS FOLLOWS:

1. Kwamba, kuanzia tarehe ya utiaji wa Saini ya mkataba huu, MUUZAJI atakuwa tayari ameshauza kwa MNUNUZI SHAMBA AMBALO HALIJAPIMWA.

That, from the date of signing this agreement the SELLER shall be deemed to have already sold the UNSURVEYED LAND PROPERTY to the BUYER.

2. Kwamba, bei ya mauziano ya SHAMBA AMBALO HALIJAPIMWA ni *Shilingi za Kitanzania Milioni Arobaini na Tano (T.Shs 45,000,000/)*, na kiasi hiki cha pesa zitalipwa kwa awamu mbili kama zifuatazo;

i. Tarehe ya kusaini mkataba huu MNUNUZI atamlipa MUUZAJI kiasi cha *Shilingi za Kitanzania Milioni Tano (T.Shs 5,000,000/=*

ii. Na kiasi kilichobaki ambacho ni *Shilingi za Kitanzania Milioni Arobaini (T.Shs 40,000,000/)* zitalipwa ifikapo tarehe 28.02.2022.

That, the purchasing price of the UNSURVEYED LAND PROPERTY is Forty-Five Million Tanzanian Shillings (T.Shs 45,000,000 /), and the said money will be paid in two installments as follows;

i. On the date of signing this agreement the BUYER shall pay the SELLER amount of Tanzanian Shillings Five Million (TZS 5,000,000/) in which One Million (TZS 1,000,000/=) shall be paid in cash and Four Million (TZS 4,000,000/=) shall be paid through bank transfer.

ii. And the remaining balance, that is, Tanzanian Shillings Forty Million (TZS 40,000,000/=) shall be paid on 28.02.2022.

3. Kwamba, *MUUZAJI* wakati anamuuzia *MNUNUZI SHAMBA AMBALO HALIJAPIMWA*, amethibitisha kwamba hakuna mtu mwingine mwenye madai yoyote au umiliki kwenye shamba hili.

That, the SELLER has confirmed that at the time of selling this UNSURVEYED LAND PROPERTY to the buyer, confirms that no one else has any claim or ownership over the said unsurveyed land property

4. Kwamba, *MUUZAJI* analazimika baada ya kusaini mkataba huu na kulipwa pes azote ikiwemo pesa ya awamu ya pili ,atamkabidhi nakala zote zinazohusiana na umiliki wa SHAMBA AMBALO HALIJAPIMWA na atakabidhi SHAMBA kwa *MNUNUZI*

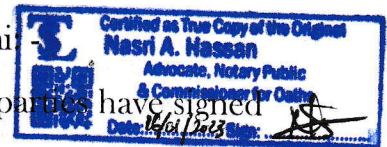
