**RE: REQUEST FOR EXTENSION OF CERTIFICATE OF INCENTIVE FOR THE PERIOD OF TWO YEARS AND CORRECTION OF PROJECT ADDRESS**

Kingdom's Business Company Limited was granted the certificate of incentive number 02-65-10 for the period of three years from February 2020 to January 2023. and this was purposed to establish and operationalize a university in Mwanza Named "**Mwanza University**".

During this period with the facilitation from TIC, we were able to establish a University (Mwanza University) in June 2021 with license No. 20210630-01 and Succeeded to accomplish all requirements to accommodate one academic programme of Doctor of Medicine degree and delayed on commencement of 4 academic Programmes.

**(1) Challenges :**

- a) Mwanza University was hindered from getting permission to enroll students and commence operationalization resulted from contradiction between University Act

(2005) and General University Regulation (2013) though ready to commence enrollment (operationalization) but the regulations required us to wait for three years June 2021 to May 2024;

- b) Delayed commencement of students' enrolment (operationalization) and changes of quality Guidelines of standards for Universities in Tanzania (2021) which rose bar to quantity and quality of academic staff for program approval. *This has led to raised demand for more financial injection to accomplish the unfinished planned activities.*

**(2) Action Taken :**

- a) Appealed to the Minister of Education for changes of investment unfriendly General University regulations of 2023 which has been successful by Government Notice of NO. 97 of 24<sup>th</sup> February 2023 (**attached extract of Government Notice**) which implies we will be able to enrol students(commence operationalization) in 2023/24 academic year;
- b) To mobilize additional funding for accomplishment of unfinished items which will assist us to accommodate additional 4 academic programmes and make the project viable and more impactful;
- c) To avoid keeping the facility without utilization, we deployed some students from our mid-level college (Tandabui Institute of Health Sciences and Technology) to utilize the facilities (**attached photographs in the progress report**).

**(3) Request Sought and Additional Information:**

- a) Extension of Certificate of incentive period to another two years
- b) Minor correction to project address to read : PLOT 1, BLOCK C – NYAMHONGOLO AREA, KISHILI WARD, MBUGANI STREET NYAMAGANA DISTRICT
- c) The additional Investment to pursue the aforementioned of 1,799,107 USD where 1,538,593USD from Tanzania local banks and 260,514 USD from own equity

We appreciate for your consideration in granting us extension of our certificate of incentive for another two years.
