

Maombi yenu yameridhiwa kwa masharti yafuatayo:-

1. Kwa mujibu wa kanuni ya 9(iii) ya Kanuni za Ugawaji Ardhi (*The land Allocation Committee Regulations, GN. No. 79 of 2001*) Kamati ya Ugawaji Ardhi (W) imekasiniwa mamlaka ya kuidhinisha maombi ya ardhi kwa ajili ya ujenzi wa Viwanda Vikubwa. Hivyo, Kamati ya Ugawaji Ardhi ya Wilaya, ambayo Kikao chake kilifanyika tarehe 06 Agosti, 2021 imeridhiwa na kuidhinisha maombi hayo chini ya Kanuni niliyoitaja.

2. Pamoja na kuidhinishiwa maombi hayo, Kiwango cha ardhi ambacho kimeazimiwa na Kamati ni Hekta 15,000 na siyo Hekta 17,000 kwa mantiki ya Mchoro wa Mipango Miji, Upimaji na Ramani zitakazoandaliwa.
3. Fomu ya Maombi (Land Form No. 19) ambayo ilitakiwa kujazwa kabla ya kikao cha Kamati ya Ugawaji Ardhi (W) itatakiwa kujazwa na kusainiwa na Wakurugenzi wa Kampuni.
4. Malipo ya mbele (*Premium*) sharti yalipwe kabla ya Kikao cha Kamati ya Ugawaji Ardhi (W). Hivyo kwa kuwa malipo hayo hayajafanywa ifikapo tarehe 06 Agosti, 2021, japo haitakiwi kuwa kizuizi cha uwekezaji, Kampuni itaendelea na shughuli mbalimbali zinazohusiana na mradi kuanzia tarehe ya kupokelewa barua hii.
5. Masharti ya aya ya 3 na 4 hapo juu, hasa aya ya 4 ambayo hayatakiwi kuwa kizuizi cha mradi, yatafanywa baadaye, Kampuni inaruhusiwa kutengeneza njia (barabara) za kuingia, na kutoka, pia za kuzunguka eneo ili kuwezesha maafisa wa Sekta ya Ardhi (W) kubaini endapo ndani ya eneo hilo kuna wananchi wenye maslahi ambao wanahitajika kulipwa fidia. Lakini pia, kuchukua majira ya nukta kwa ajili ya uandaaji wa Mchoro wa Mipango miji na baadaye upimaji wa eneo.
6. Kwa msisitizo utokanao na uhitaji wa wawekezaji, na kutokana na zoezi la uandaaji wa Hati ya Ardhi kuchukua muda mrefu, ikiwa ni pamoja na taratibu za ukamilishaji wa kuidhinishwa kwa Mchoro wa Mipangomiji; na Upimaji na Ramani, Kampuni yako inaweza kuendelea na shughuli mbalimbali katika eneo la uwekezaji.



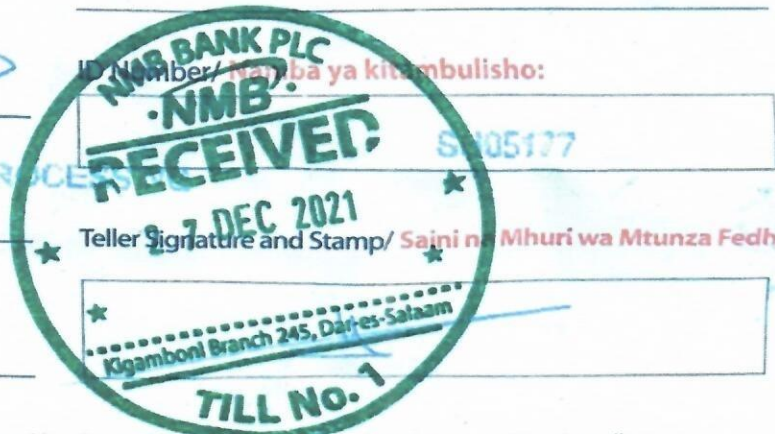
