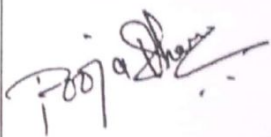
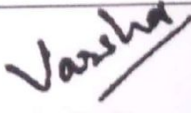
1. The name of the company is "Chem Spec Tanzania Limited"
2. The Registered office of the Company will be situated in Tanzania Mainland.
3. The objects for which the Company is established are:-
 - a). 4669 - Wholesale of waste and scrap and other products n.e.c.
 - b). 4610 - Wholesale on a fee or contract basis
 - c). 4773 - Other retail sale of new goods in specialized stores
 - d). 4661 - Wholesale of solid, liquid and gaseous fuels and related products
 - e). 4653 - Wholesale of agricultural machinery, equipment and supplies
 - f). 2029 - Manufacture of other chemical products n.e.c.
 - g). 2821 - Manufacture of agricultural and forestry machinery
 - h). 1702 - Manufacture of corrugated paper and paperboard and of containers of paper and paperboard
 - i). 1701 - Manufacture of pulp, paper and paperboard
 - j). 1709 - Manufacture of other articles of paper and paperboard
 - k). 1311 - Preparation and spinning of textile fibres
 - l). 5813 - Publishing of newspapers, journals and periodicals

That the meaning of any general word or words in any paragraph of this clause shall not be restricted by being construed ejusdem generis with any particular word or words in the same paragraph.

4. The Liability of the Members is Limited.
5. The capital of the Company is Shillings 1,000,000/= divided into 1,000 shares of Shillings 1,000/= each.

The Company shall have powers to increase its capital and to divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such preferential, deferred or special rights, privileges, or conditions as may be determined by or in accordance with the Articles of Association of the Company.

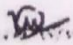
