First of all, we humbly extend our sincere appreciation to you and the entire office for the generous support which you have been giving our Company from the time we started the project to date, through the grant of Certificate of Incentives on 16<sup>th</sup> April, 2021 for the term of three years and Strategic Investor Status by the letter dated **22<sup>nd</sup> February, 2022** with Reference **No. TICC/CCA.188/2344/MAN/20214355/30**. The granted incentives were very valuable for the success of the project as whole.

We are appreciating the fact that, for a period of three years (Certificates of Incentives period) we have been able to import machines, plants and materials without the disturbance of tax demands from the taxing authority while waiting for the granted incentives to be Gazzetted by the Government of which some of them have been gazzeted recently.

Kindly be informed that, we are currently in the final stage of completing phase one of building and installing machines for PLANT LINE I-III which will enable us to produce organic fertilizers to the tune of 600,000 metric tons per year in full capacity. Furthermore, following the directives of Prime Minister Hon Majaliwa, we are currently in the process of expanding the project to PLANT LINE IV & V which will enable the production of 400,000 metric tons of organic fertilizers and make the total of 1,000,000 metric tons per year in full capacity.

However, it should be noted that the Certificate of Incentives granted on 16<sup>th</sup> April, 2021 was intended to operate up to 15<sup>th</sup> April, 2024, while the granted Incentives

were intended to be implemented for five years from the date of signing the performance contract (05<sup>th</sup> April, 2022) as per performance contract.

Taking into consideration the fact that there was a delay in gazzeting the granted incentives up until 08<sup>th</sup> September, 2023, we humbly request for the extension of time of the Certificate of Incentives which shall expire on 15<sup>th</sup> April, 2024 so that we can enjoy the same for the intended period of five years as per agreed performance Contract and consideration of the date of Government Notice gazzete.

We hope that our request will merit the understanding and approval from the authorities in charge.
