We write to you with regards to the above captioned heading, referring to our TIC Certificate number:**0224034**.

Further to the original certificate you had given us of number **022335** issued on the 15th May 2019 for 3 years until 14th May 2022, thereafter, we had applied for the 1st extension of one year from 15th May 2022 to 14th May 2023, which was obtained via TIC Certificate number: **0224034** and a successful re-application for another one year was made on 14th May 2023 to 23rd June 2024 via the same TIC certificate number.

We appreciate for the support extended for the extensions however, as reported in our earlier letters to you dated 27th June 2022 and 2nd June 2023 , the reality remains that we were unable to execute on the business plans during the year **15th May 2019 to 14th May 2022** (3 years) due to the global pandemic COVID 19 which adversely impacted the Tourism Industry, perhaps more so than any other sector of the economy. The impact was devastating, and we are thankful that we were able to survive through that very challenging period. As you are aware, the tourism business declined due to several countries facing lockdowns with hardly any visitors coming into the country for almost 3 years. During this time, several international airports in the tourism generating/source countries had closed down also.

Within this period, we were unable to execute on our business and new investment plan due to the force majeure pandemic and hence lost 3 years benefit the 1st TIC exemption. As per the enclosed and earlier progress reports, we were able to start the investment plan in earnest from early March 2023 up to date.

We therefore request your esteemed office to kindly consider our situation and give us an extension of 3 more years for us to complete our desired project and objectives, whereby, we are looking to purchase an additional **30 more units of Toyota Landcruiser 4 wheel drive Pickups**. We trust you will understand and consider our situation and grant us the extension of implementation up to 2027. We remain available for any further clarification as may be required.
