

LEASE AGREEMENT

BETWEEN

THABITA HARUNA HEMBE

AND

ZANDEN COMPANY LIMITED

THIS LEASE AGREEMENT is made this day of 2020

BETWEEN

THABITA HARUNA HEMBE of P. O. Box 8812 Dar es Salaam. (herein after referred to as the "LANDLORD", which expression where the context so admit shall include his heirs and assignees) of one part.

AND

ZANDEN COMPANY LIMITED a Company duly registered under the Companies ACT, (Cap, 212, R.E 2002) of P.O Box 38202, Dar es Salaam, (herein after referred to as the "TENANT"), which expression where the context admit shall include her successor or assignees) of the other part.

- A. WHEREAS**, the **Landlord** is the lawful owner of said **MADODO VILLAGE-MWANAMBAYA MKURANGA -COAST REGION**
- B. WHEREAS**, the **Tenant** is desirous and willing to rent the said part of the premises subject the terms and conditions hereinafter set forth.

NOW THEREFORE, This **DEED** witness as follows.

IT IS HEREBY MUTUALLY AGREED AS FOLLOWS: -

1. The Landlord shall
 - a) That this lease agreement will be for a term of ten (4) years, stating from 1th March, 2024 and as witnessed in the Lease Agreement between **THABITA HARUNA HEMBE** and **ZANDEN COMPANY LIMITED** which will be reviewed after every five years periods.
 - b) **YIELDING AND PAYING** therefore and throughout the said term of 24 month at a rent of Tanzanian Shillings 800,000 only, payable in advance for a period of every twenty-four months with effect from 1th March, 2024.
2. The Landlord undertakes that, the Tenant shall enjoy the facilities of the leased premises without any interference from the Landlord, his family members or his worked upon for a further period of five years.
3. At the expiry of the initial period of Five years the Tenant shall enter into renegotiation or reviewing favorable terms upon which the renewal of contract will be, worked upon for a further period of Five years.

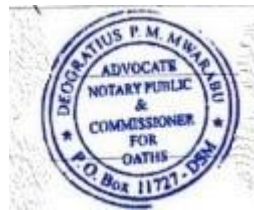
4. The contracting parties have executed this Lease Agreement on date and year hereinafter appearing.
