

- 1. The name of the Company is J & Z BROTHERS TANZANIA LIMITED.**
- 2. The registered office of the company will be situated in Tanzania**
- 3. The Object for which the company is established are;-**
  - (a) To conduct and carry on the manufacturing of motorcycle Rubber tyres and tubes.
  - (b) To conduct and carry on the manufacture of Dyeing cloth,
  - (c) To conduct and carry on the Sponge Factories,
  - (d) To provide or procure the provision of every and any service of facility required by any person, firm or company, and in particular to provide agency, corporate, office and business services to any person, firm or company,
  - (e) To conduct and carry on the manufacture of Textiles,
  - (f) To engage in and carry on the business of brokers and dealers in commodities, including contracts for future delivery thereof, of every kind, character, or description whatsoever,
  - (g) To carry on business as financiers, industrialists, financial agents, concessionaires, brokers, merchants, commercial agents, mortgage and bullion brokers and financial agents and advisers and to undertake and carry on and execute all kinds of financial, commercial, trading, manufacturing, industrial and other operations,
  - (h) To do and perform all such other acts as may be necessary for attainment of the objects of the company.
- 4. The Liability of the members is Limited.**

5. The share capital of the company is Tanzania shillings Seven Hundred Fifty Million

(750,000,000/=), divided into One Hundred (100) Ordinary shares of Tanzania shillings Seven Million Five Hundred Thousand (7,500,000/=) each. The company shall have power to increase or reduce its capital and to divide the shares in its capital for the time being into different classes of stock or shares and to attach thereto respectively preferential, deferred, qualified or special rights, privileges or conditions in accordance with the Articles of Association of the company.
