


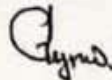
**THE COMPANIES ACT [CAP 212]
COMPANY LIMITED BY SHARES
MEMORANDUM OF ASSOCIATION
OF
GIGA PREMIUM CARGO LIMITED**

1. The name of the Company shall be GIGA PREMIUM CARGO LIMITED
2. The registered office of the Company shall be situating in United Republic of Tanzania.
3. The objects for which the Company is established are:-
 - (i) To conduct the business of air and sea freight services.
 - (ii) To engage in the business of air courier express.
 - (iii) To carry on the business of domestic courier and third party shipping.
 - (iv) To carry on door to door to door transportation business.
 - (v) To conduct the business of Worldwide Exportation and Importation of cargo through all means of Transportation, Such as Airways, Railways, Etc.
 - (vi) To engage in the Haulage business nationally and internationally.
 - (vii) To carry on the business of printing services, selling and distribution of office stationeries.
 - (viii) To do the business of providing all logistic services.
 - (ix) To carry on the business as a General Commercial Company.

AND IT IS HEREBY DECLARED that the word "Company" save when used in reference to this Company, in this clause shall be deemed to include any partnership and any other body of persons, whether domiciled in East Africa or elsewhere and the intention is that the objects specified otherwise expressed in each paragraph of this clause shall except where otherwise expressed in such paragraph be independent main objects and shall in no wise be limited or restricted by a reference to or inference from the terms of any other paragraph or the name of the company.

4. The liability of the members is Limited.
5. The authorised share capital of the Company is Tanzania Shillings One Million Only (Tsh. 1,000,000/=) at the date of registration divided into 100 ordinary shares of Tanzania Shillings Ten Thousands Only (Tsh. 10,000/=) each with such rights, privileges or conditions as may be determined by or in accordance with the regulations of the Company, and to vary, modify or abrogate any such rights, privileges or conditions in such manner as may for the time being be provided by the regulations of the Company.

We, the several persons whose names, addresses and descriptions are subscribed, are desirous of being formed into a company in pursuance of this Memorandum of Association and we respectively agree to take the numbers of shares in the capital of the company set opposite our respective names.

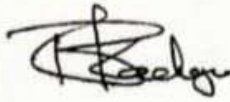

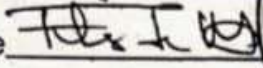
