

We hereby apply for amendment of Certificate of Incentive to add also Plot No. 263 Block "FF" Industrial Area, Msamala, Songea Municipality, Ruvuma Region as Project Location for Cargo Transportation and Logistics Services East and Central Africa. The area has been purchased by the company from one SESILIA FRANCIS KOMBA of P. O. Box 30073 Kibaha. At the time of purchase, the land was known as Plot No. 19, Industrial Area, Msamala, Songea Municipal
