**MEMORANDUM OF ASSOCIATION**

**Greenlife Chemical Industrial Limited**

1. The name of the company is **GREENLIFE CHEMICAL INDUSTRIAL LIMITED**
2. The Registered office of the company will be situated in Tanzania
3. The objects for which the company is established are:
  - a) To engage in retail and whole sale of chemical and processed chemical-related products.
  - b) To build manufacturing plant for chemicals production. To engage as an importer of chemical and chemical raw materials processing machinery and equipment.
  - c) To carry on the business of manufacturing chemicals and chemical-related products.
  - d) To carry on the business of locally purchasing or importing of raw materials for chemical industry.
  - e) To engage as importer, exporter and transporter of chemicals and chemical-related products.
  - f) To establish and carry on the business of applying for, selling and holding the Prospecting Licence and Mining license for minerals mining as chemicals production raw materials
  - g) To carry the business of exploration and mining of raw mineral for chemicals.
  - h) To carry the business of investment and operation of mineral mining and mineral purification processing plants.
  - i) To provide technical training and consulting obligations.
  - j) To carry the business of logistics and transportation.
  - k) To sell mineral manufactured by the company in or – outside Tanzania.
  - l) To carry on the business of the manufacturer, buyer, seller, importer, exporter and dealer in all sorts of mineral as permissible under the laws of Tanzania.
  - m) To engage in the business of marketing and promotion of business mentioned above.
  - n) To engage in the business of importing and selling all kinds of moving machines, petrol and diesel engines, tools, plants, tractors, equipment, motor vehicles, spares or otherwise.
  - o) To let out on hire all or of the property of the company (whether real or personal), including every description of apparatus or appliances of the company.
  - p) To carry on any other business, whether manufacturing or otherwise, which may seem to the company capable of being conveniently carried on in connection with the above or calculated or indirectly to enhance the value of or render more profitable any of the company's property.
4. The Liability of the Members is Limited.
5. The capital of the company is Tanzanian Shillings 2,300,000/= divided into 100 shares of Shillings 23,000/= each. The company shall have powers to increase its capital and to divide the shares in its capital for the time being into several classes of stock or shares and to attach thereto respectively such preferential, deferred or special rights, privileges,



or conditions as may be
