  - c. 5590 - Other accommodation
  - d. 5520 - Camping grounds, recreational vehicle parks and trailer parks
  - e. 5610 - Restaurants and mobile food service activities
  - f. 5629 - Other food service activities
  - g. 5621 - Event catering
  - h. 5630 - Beverage serving activities
  - i. 7990 - Other reservation service and related activities
  - j. 7490 - Other professional, scientific and technical activities n.e.c.
