- 1 The name of the Company **STALWART ILMA TANZANIA LIMITED**
- 2 The registered office of the Company will be situated in the United Republic of Tanzania.
- 3 The objectives for which the Company is established are
 - a) Wholesale on a fee or contract basis Main
 - b) Freight transport by road
 - c) Urban and suburban passenger land transport
 - d) Other passenger land transport
 - e) Warehousing and storage
 - f) Cargo handling
 - g) Wholesale of food, beverages and tobacco
 - h) Wholesale of other machinery and equipment
 - i) Other retail sale of new goods in specialized stores
 - j) Other retail sale in non-specialized stores
 - k) Support activities for other mining and quarrying
 - l) Short term accommodation activities
 - m) Beverage serving activities
 - n) Restaurants and mobile food service activities
 - o) Event catering
 - p) Real estate activities with own or leased property
 - q) Real estate activities on a fee or contract basis
 - r) Manufacture of gas; distribution of gaseous fuels through mains
 - s) Tour operator activities
 - t) Travel agency activities
 - u) Other financial service activities, except insurance and pension funding activities, n.e.c.



4) The liability of the Members is limited.

5. The Share Capital of the Company is Tanzania shillings 500,000,000/= only, divided into 1000 ordinary shares each of Tanzania shillings Tsh500,000/= only, subject and to the rights attached to any class of shares for the time being carrying special rights whether as part of the original or any special, qualified preferred or deferred rights and privileges, or conditions as to capital dividends, rights deferred rights and privileges, or conditions as to capital dividends, rights of voting or other matters but so as that any such rights privileges or conditions **SHALL NOT** be altered or modified except in accordance with the Articles of Association of the Company for the time being in force
