
have to settle down an Investment Entrance Fee with us (To be discussed and agreed between us),  
The village entrance condition which you have initially agreed with them, also to settle down  
ownership of land to any land which you intend to acquire and it is not part of the Village land or Our  
land (land possessed by ordinary persons) for the compensation.

That since you are a foreign Company to which Our Permission is tied to assist you on initial stages  
particularly in settling land ownership, after setting the above issue, we will put the settled issues into  
writing either by a contract or Memorandum of Understanding (M.O.U) which will be signed by both
