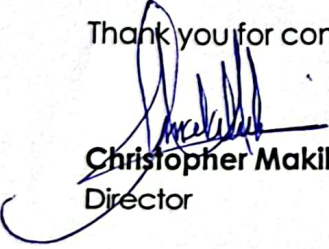
• **Export Potential:**
