**EXPRESSION OF INTEREST IN MEMBERSHIP AT TANZANIA INVESTMENT CENTRE (TIC)**

I am writing to express our keen interest in becoming a member of the Tanzania Investment Centre (TIC) for two of our newly incorporated companies which are namely Mwamba Lodge Tarangire Limited – Incorporation No. (“Mwamba Lodge”) and Great Lakes Adventure Limited – Incorporation No. (“Great Lakes Adventure”) (Mwamba Lodge and Great Lakes Adventure are hereinafter collectively referred to as “the Companies”).

The principal shareholders of the Companies are Great Lakes Safaris Limited which is a company incorporated in Uganda with over 25 years of experience, as a prominent player in the safari and lodges business, with offices based in Uganda and Rwanda; operating across East Africa.

In Tanzania under Mwamba Lodge, we have recently executed a long term lease with Lolkisale Village Council (“LVC”) and Boundry Hill Lodge Limited – In Receivership (“BHL – In Receivership”) for purposes of operating an international tourist lodge and related hospitality business in an investment worth circa one million dollars in the form of renovations and development of the leased property with a view to commencing full operations by June 2024. It is with this background that we consider membership with TIC would be a valuable relationship for us as new entrants into the Tanzanian hospitality and tourism sector.

We are impressed by the TIC’s role in encouraging, promoting, and facilitating investment in Tanzania, and we believe that our company’s extensive experience and regional presence make us a valuable potential member. We are particularly interested in the incentives offered by the TIC, such as the import duty exemption, as we continue to expand our operations in the region.

Our commitment to the East African market and our track record of successful investment in the region make us confident that TIC membership will not only benefit our company but also contribute to the economic development of Tanzania.

We have attached all of the necessary documents as per the TIC registration requirements, which include as follows:


- 1) Certified true copy of the certificate of incorporation
