3. The objects for which the Company is established will be:-

 - c. To facilitate and carry business of profession of transporters, farmers, business people and any other business in connection with transport, logistics and agriculture.
 - d. To carry on the business of transport, logistics of all kinds of species, chemicals including industrial chemicals and all products.
 - e. To carry on the business of buyers, sellers, traders, importers, exporters, manufacturers, processors, commission agents, distributors, dealers and representatives in any legal form for all kinds of transports and logistics including but not limited to all services related to transport and logistics.

 - h. To carry on and deal in the business of hardware, transport, logistics, manufacturing, making and selling of hardware products services,





