

**LEASE AGREEMENT**

**BETWEEN**

**RICHARD OSWARD MAHUNDI**

**AND**

**ALKANET (T) LIMITED**

**THIS LEASE AGREEMENT** is made this 12<sup>th</sup> day of January 2024

**BETWEEN**

RICHARD OSWARD MAHUNDI of P.O. Box 1056, Songea, Ruvuma, Tanzania,(herein after referred to as the “LESSOR”, which expression where the context so admit shall include his heirs and assignees) of one part.

**AND**

**ALKANET (T) LIMITED** a Company duly registered under the Companies ACT, (Cap, 212, R.E 2002) of P.O.Box 72466, Dar es Salaam (herein after referred to as the “LESSEE”), which expression where the context admit shall include her successor or assignees) of the other part.

A. **WHEREAS**, the **Lessor** is the lawful owner of said Plot located at Liweta Area, District: Nyasa situated at Ruvuma Region.

B. **WHEREAS**, the **Lessee** is desirous and willing to rent the said part of the premises subject the terms and conditions hereinafter set forth.

**NOW THEREFORE**, This **DEED** witness as follows.

**IT IS HEREBY MUTUALLY AGREED AS FOLLOWS: -**

1. The Landlord shall
  - a) That this lease agreement will be for a term of five (5) years, stating from 12<sup>th</sup> January, 2024 and as witnessed in the Lease Agreement between **RICHARD OSWARD MAHUNDI** and **ALKANET (T) LIMITED** which will be reviewed after every five years periods.

- b) **YIELDING AND PAYING** therefore and throughout the said term of 24 month at a rent of United States Dollar 28,800 USD only, payable in advance for a period of every twenty-four months with effect from 12<sup>th</sup> January, 2024.
2. The Lessor undertakes that, the Lessee shall enjoy the facilities of the leased premises without any interference from the Landlord, his family members or his worked upon for a further period of five years.
  3. At the expiry of the initial period of Five years the Tenant shall enter into renegotiation or reviewing favorable terms upon which the renewal of contract will be, worked upon for a further period of Five years.
  4. The contracting parties have executed this Lease Agreement on date and year hereinafter appearing.
  5. This **LEASE** Agreement shall be governed by and constructed in accordance with the laws of Tanzania Governing Lessor and Lessee relationship as shall be in force
