

1. The name of the Company is **ENPRIZON COMPANY LIMITED**;
2. The registered office of The Company will be situated in the Tanzania Mainland.
3. The objects for which the company is being established are:-
 - (i) To buy, sell, manufacture and deal in all types of minerals, to carry on the business of mining, setting and refining any of type of minerals, jewelers etc.
 - (ii) To carry on the business of support activities of mining and quarrying, mining of other non-ferrous metal ores and all related materials.
 - (iii) To import, export, wholesale and retail different types of minerals such as gold, iron ore, coal, copper, Tanzanite, silver and many more.
 - (iv) To carry on all or any of the business of quarrying of stone, sand and clay and all other related activities.
 - (v) To carry on business of whole sale, retail, sourcing, importing, supply, maintenance, installation, and serving telecommunication equipment, electronic equipment electrical equipment and appliances.
 - (vi) To arrange in Tanzania and abroad for the marketing, advertising and sale of the products and by-products of the Company and purchase of raw materials, goods and articles as necessary for carrying on the business of the Company and, for that purpose, either to establish its own shops, agencies, or marketing organization or to appoint selling or buying agents or distributors of both (whether individuals, firms or bodies corporate) in any place in or outside Tanzania and to allot, specify, alter or modify their areas of operation or the terms and conditions of their appointment and to pay remuneration to such selling or buying agents or distributors or both by way of such commission or in such other manner as the Company may deem fit.

- (vii) To carry on the business of printing and publishing text books, stationeries, exercise books, calendars, diaries; suppliers of school equipments, laboratory equipment, book, desks, tables and generally school and office furniture's.
- (viii) To carry on the business of fuel, deal in petrol, diesel, oil, kerosene, mineral oil, crude oil, lubrication oil, grease, and/or trade as fuel importers, dealers or distributors and engage in the servicing and repairing of vehicles of all types generally and other machineries; and to trade as dealers, wholesalers, retailers, distributors, agents, importers and exporters of hardware.
- (ix) To carry on the business of distribution across the country of cellular scratch cards, starter packs, handsets and any other business connected thereto.
- (x) To conduct and deal with the business of cultural safaris and area photographing, tours operators, travel agency, internet coffee, secretarial services, real estates, real estate agents.
- (xi) To enter into joint venture with local and foreign partners, investors and or dealers for the purpose of carrying out all the businesses herein above mentioned. To carry on and/or undertake the business of Marketing, Distribution and selling of food and food product, manufactured consumer goods and any other business directly related and or connected to the foregoing.
- (xii) To establish and carry on the business of stationeries, type writing, secretarial services, photocopying, duplicating, lithographic stereotyping, printing, binding, supply and servicing of computers, computer wares (Hardware's and software's), servicing of office machines and any other work directly and or indirectly connected to the foregoing objectives.
- (xiii) To engage in importation and sale of new and reconditioned house wares materials, freezers, televisions sets, music systems, computers, laundry machines and deal in dry clearing business, and importation of office and school and school equipments sports equipments, and laboratory equipments and any other related business.
- (xiv) To carry on the business of exporting, buying and selling of fish and fish products, fishing, fish boats and engines etc. To import, purchase and sell all kind of hospital equipments, drugs, medicines and to operate the business of Hospital, Clinic, Pharmacy, Laboratory Services and consultancy and any other business directly related to the foregoing.
- (xv) To undertake the business of importing and selling of all kind of building materials and to carry on the business of construction of buildings, schools, laboratories, bridges, road, highways and to deal in all types of engineering works, civil mechanical electrical and chemical engineering works of whatever nature and enter into agreement with other parties for purposes carrying on the aforesaid objectives as contractors, subcontractors, engineers etc.

(xxxv) To do all or any of the above things in any part of the world and as principals, Trustees, agents, contractors, or otherwise and by or through trustee, agents, or otherwise and either alone or in conjunction with others.
