


1. The name of the Company **EASTERN GENERAL DEALERS LIMITED**

3. The objects for which the Company is established are:
 - (a) To carry on business of spare parts including nuts and bolts, rivet screws, nails, roofing nails, radiators, valves, crankshafts, springs, door handles, and locks, bushes, electrical fittings including wires, switches, plugs, sockets, distribution boxes and to carry on all or any of the business of repairman, electrical contractors, including drills, spanners, hydraulic jacks and implied purposes of running garage, including trucks, lorries, cars, any other power propelled vehicles and machinery, transportation, cargo and travel agents, commission agents, customs agents, insurance agents, tourist agents, manufacturers representative, clearing and forwarding agents..
 - (b) To carry on business of Other transportation support activities clearing and freight forwarding, customs agency, shipping agency, inland containers depot, cargo warehousing, hiring cranes, loaders, and lifting equipments, logistics, transportation of cargo transportation, passengers, stones, quartz and general transportation.
